**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Obstruct Legal Process-Interfere w/Peace Officer**

Minnesota Statute: 609.50.1(2), with reference to: 609.50.2(2)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 08/02/2026

Control #(ICR#): 26024276

Charge Description: On or about August 2, 2026, in the County of Blue Earth, Minnesota, Dominick Leonardo Ramirez did, intentionally, obstruct, resist, or interfere with a peace officer while the officer was engaged in the performance of official duties and the act was accompanied by force or violence or the threat thereof.

**COUNT II**

**Charge: Fleeing a Peace Officer By a Means Other Than a Motor Vehicle**

Minnesota Statute: 609.487.6

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 08/02/2026

Control #(ICR#): 26024276

Charge Description: On or about August 2, 2026, in the County of Blue Earth, Minnesota, Dominick Leonardo Ramirez, did, for the purpose of avoiding arrest, detention, or investigation, attempted to evade or elude a peace officer who is acting in the lawful discharge of an official duty, by means of running, hiding or any other means other than fleeing in a motor vehicle.

**COUNT III**

**Charge: Disorderly Conduct - Brawling or Fighting**

Minnesota Statute: 609.72.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 08/02/2026

Control #(ICR#): 26024276

Charge Description: On or about August 2, 2026, in the County of Blue Earth, Minnesota, Dominick Leonardo Ramirez, did, in a public or private place, knowing, or having reasonable grounds to know it will, or will tend to, alarm, anger or disturb others or provoke an assault or breach of the peace, engaged in brawling or fighting.

## **STATEMENT OF PROBABLE CAUSE**

On August 2, 2026, Officers Gelle and Wagner of the Mankato Department of Public Safety were working in the downtown Mankato area. Officer Gelle observed an individual, who was later identified as Dominick Leonardo Ramirez, take a swing at a different individual.

Officer Gelle commanded Ramirez to stop and announced himself as the police. Ramirez took off running. A foot pursuit ensued. While fleeing, Ramirez tripped and fell. Officers tried to gain control of Ramirez. Ramirez actively resisted officers, including forcefully pushing of the ground towards officers and trying to push officers. Eventually, officers were able to arrest Ramirez.
