The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Domestic Abuse No Contact Order - Violate No Contact Order - within 10 years of previous conviction**

Minnesota Statute: 629.75.2(c)

Maximum Sentence: 10 days to 364 days or \$3,000 fine, or both.

Offense Level: Gross Misdemeanor

Offense Date (on or about): 05/24/2026

Control #(ICR#): 26016196

Charge Description: On or about May 24, 2026, in the County of Blue Earth, Minnesota, Kathleen Ann Ball did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order and the violation occurred within ten years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency.

**COUNT II**

**Charge: Trespass-Occupy/Enter Dwelling/Locked/Posted Build**

Minnesota Statute: 609.605.1(b)(4)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 05/24/2026

Control #(ICR#): 26016196

Charge Description: On or about May 24, 2026, in the County of Blue Earth, Minnesota, Kathleen Ann Ball did occupy or enter the dwelling or locked or posted building of another, without claim of right or consent of the owner or the consent of one who has the right to give consent, except in an emergency situation.

## STATEMENT OF PROBABLE CAUSE

On May 8, 2026, a district court judge issued a domestic abuse no contact order that prohibited Kathleen Ann Ball, dob 8/28/1986, from having any contact with Protected Party. The order also prohibited Ball from going wherever Protected Party resided. The order was served on Ball.

On May 26, 2026, officers of the Mankato Department of Public Safety were dispatched to a residence in Mankato, Minnesota, Blue Earth County, on report that Ball had entered Protected Party's residence.

Officers spoke on the phone with Protected Party who was out of town. Protected Party stated that he had cameras inside his house and observed Ball inside his residence on May 24th, 2026. Officers observed different camera angles from inside the house. Ball is seen on camera placing a blanket over the cameras.

Ball was not located.

Ball was later arrested when she entered Protected Party's residence again.

Ball has a prior conviction for Harassment Restraining Order—Violate on July 21, 2023.
