**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Fleeing a Peace Officer in a Motor Vehicle**

Minnesota Statute: 609.487.3

Maximum Sentence: 3 years and one day or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 02/13/2026

Control #(ICR#): 26004503

Charge Description: On or about February 13, 2026, in the County of Blue Earth, Minnesota, Michael David Bustos Corbett did by means of a motor vehicle, flee or attempt to flee a peace officer who is acting in the lawful discharge of an official duty, and the perpetrator knows or should reasonably know the same to be a peace officer.

**COUNT II**

**Charge: Traffic - DWI - Refuse to submit to chemical test; Breath or test refusal or failure**

Minnesota Statute: 169A.20.2(1), with reference to: 169A.26.2

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 02/13/2026

Control #(ICR#): 26004503

Charge Description: On or about February 13, 2026, in the County of Blue Earth, Minnesota, Michael David Bustos Corbett, did, drive, operate, or was in physical control of any motor vehicle and the Defendant refused to submit to a chemical test of the person's breath upon the request of a peace officer who had probable cause to believe the person to be tested was under the influence.

**COUNT III**

**Charge: Drivers' Licenses - Display/Possess Fictitious or Fraudulently Altered DL or MN ID**

Minnesota Statute: 171.22.1(1)

Maximum Sentence: 90 days in jail and/or a fine of \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 02/13/2026

Control #(ICR#): 26004503

Charge Description: On or about February 13, 2026, in the County of Blue Earth, Minnesota, Michael David Bustos Corbett did display, cause or permit to be displayed, or have in possession, any fictitious or fraudulently altered driver's license or Minnesota identification card.

## STATEMENT OF PROBABLE CAUSE

On February 13, 2026, at approximately 1:40 AM, Officer Rutz of the Mankato Department of Public Safety was on patrol in Mankato, Minnesota, Blue Earth County. Officer Rutz observed a vehicle that was traveling faster than the speed limit. Specifically, Officer Rutz clocked the vehicle going 49 mph in a 30 mile-per-hour zone. Officer Rutz attempted a traffic stop, but the vehicle sped away. The vehicle struck curbs and eventually went into a parking lot and struck another curb while it fled. The vehicle eventually stopped.

Officer Rutz identified the driver as Michael David Dustos Corbett (dob 4/27/2006). Corbett stated he didn't stop because he was scared. Officer Rutz smelled the odor of alcohol coming from the vehicle. Officer Rutz also observed Corbett had bloodshot/watery eyes and slurred speech.

Officer Rutz had Corbett step out of the vehicle to perform from standard field sobriety tests. Throughout the tests, Officer Rutz observed signs of impairment. Corbett declined a preliminary breath sample.

Officer Rutz read Corbett the Minnesota breath test advisory. Corbett refused to provide a breath test.

On Corbett's person, officers found a fictitious driver's license which appeared to have a photograph of Corbett but a date of birth of 4/27/2002 instead of his real date of birth of 4/27/2006.

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
