The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Theft-Take/Use/Transfer Movable Prop-No Consent**

Minnesota Statute: 609.52.2(a)(1), with reference to: 609.52.3(2)

Maximum Sentence: 10 years or \$20,000, or both (over \$5,000)

Offense Level: Felony

Offense Date (on or about): 10/01/2024

Control # (ICR#): 24027337

Charge Description: On or about October 1, 2024, in the County of Blue Earth, Minnesota, Codie James Tesch, did, intentionally and without claim of right take, use, transfer, conceal or retain possession of the movable property of another without the other's consent and with intent to deprive the owner permanently of possession of the property and the value of the property or services stolen exceeded \$5,000.00.

## STATEMENT OF PROBABLE CAUSE

On October 1, 2024, at about 4:15 p.m., officers of the Mankato Department of Public Safety were dispatched to investigate a motor vehicle theft that had just occurred in Mankato.

Victim 1 reported that their 2022 Kia Rio with license plates ending 318 was stolen. The Kia had been parked on Walnut Street facing a building. Victim 1 turned off the Kia and brought the keys with them into a business. Victim 1 witnessed a black male in his 20s steal the Kia and drive through an alley toward Riverfront Drive.

CCTV recorded the theft. At 4:12 p.m., an approximately six-foot man approached the Kia. He was wearing a baggy, blue/black hooded sweatshirt and grey pants. The male got into the Kia and drove away. The Kia was entered into a nationwide data base and noted as stolen.

At 7:54 p.m., Owatonna police reported that they had recovered the stolen Kia and arrested Codie James Tesch (DOB 10/04/1998). Tesch was observed driving a stolen Pontiac and pulled up to the Kia which was at a gas pump. Tesch began loading things from the Kia into the other vehicle. The owner of the Pontiac was able to get into the car and drive away. Tesch was approached by officers and ran away. Tesch was apprehended by Owatonna police.

An officer noted that Tasch had on multiple layers of pants, including the grey pants in the Mankato CCTV. Tesch admitted driving the Kia and freaking out when he could not restart it. Tesch told officers that he believed the vehicle belonged to him.

The registered owners of the vehicle told Mankato officers that they had not given Tesch permission to use the Kia. The Kia had been recently purchased by the owners for approximately \$20,000.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
