The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Nonconsensual dissemination of private sexual images - Intentionally disseminate image w/out consent**

Minnesota Statute: 617.261.1

Maximum Sentence: 3 years or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 12/29/2024

Control #(ICR#): 24001799

Charge Description: On or about December 29, 2024, in the County of Blue Earth, Minnesota, Bryon Allen Hansen did intentionally disseminate an image of another person depicted in a sexual act or whose intimate parts are exposed, in whole or in part, when the person was identifiable from the image itself, by the person depicted or by another person, or from personal information displayed in connection with the image, knowing or having reason to know, that the person depicted in the image does not consent to the dissemination, and the image was obtained or created under circumstances in which Bryon Allen Hansen knew or had reason to know the person depicted had a reasonable expectation of privacy, and the defendant disseminates the image with intent to harass the person depicted in the image.

**COUNT II**

**Charge: Domestic Abuse No Contact Order - Violate No Contact Order - Misdemeanor**

Minnesota Statute: 629.75.2(b)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 12/29/2024

Control #(ICR#): 24001799

Charge Description: On or about December 29, 2024, in the County of Blue Earth, Minnesota, Bryon Allen

Hansen did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order.

## STATEMENT OF PROBABLE CAUSE

On December 29, 2024, Ofc. Robert Roelofs, with the Mapleton Police Department, spoke with Victim 1 who had reported that her former romantic partner, Bryon Allen Hansen, had stolen her cell phone and was sending messages and photos from her phone to other persons, including her teenage daughter, Witness 1.

On January 4, 2025, Chief Ben Honsey with the Mapleton Police Department spoke with Victim 1 and Witness 1. Victim 1 reported to Chief Honsey that Hansen had taken her cell phone and was sending messages to Victim 1's daughter's phone. Victim 1 stated that the messages were received while they were in Blue Earth County.

Witness 1 sent screen shots of the text messages she had received on her cell phone from Hansen as well as audio messages she had received on her cell phone from Hansen. Victim 1 told Chief Honsey that some of the photos were explicit sexual photos. Hansen did not have consent to disseminate the explicit sexual photos. Chief Honsey was given a screenshot of the explicit sexual photos that were sent to Witness 1's phone. The photos show the intimate parts of both Victim 1 and Hansen. Victim 1 was able to identify that the picture was of her and Hansen. The images were sent to Witness 1 on December 28, 2025.

Between December 28, 2025 and December 29, 2025, Hansen sent 10 voice messages to Witness 1. The messages were intended for Victim 1, as is apparent when the first of the messages addresses Victim 1 by her name. The messages are filled with profanity and name-calling ("idiot" "dirty fuck" "fucking retarded" "motherfucker"). In the messages Hansen threatens to contact everyone on Victim 1's contact list. Hansen states he is going to "go ballistic on your phone."

Hansen also threatens to "fuck with your Facebook." Chief Honsey was provided with snapshots of Victim 1's Facebook feed. Hansen posted numerous items on Victim 1's Facebook feed that were available for persons to read, including calling Victim 1 a "drug slut" and a "drug addict" and stating that CPS should take Victim 1's children from her.

There were two Domestic Assault No Contact Orders (DANCO's) in place at the time that prohibited Hansen from contact with Victim 1. The DANCO's can be found in Blue Earth County files 07-CR-24-4071 and 07-CR-24-5027.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
