COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 3rd Degree - Sale - Narcotic

Minnesota Statute: 152.023.1(1), with reference to: 152.023.3(a)

Maximum Sentence: 20 years or \$250,000, or both

Offense Level: Felony

Offense Date (on or about): 07/29/2025

Control #(ICR#): 25021539

Charge Description: On or about July 29, 2025, in the County of Blue Earth, Minnesota, Orondi Buggs, did, unlawfully sell one or more mixtures containing a narcotic drug.

COUNT II

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/29/2025

Control #(ICR#): 25021539

Charge Description: On or about July 29, 2025, in the County of Blue Earth, Minnesota, Orondi Buggs, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe and said controlled substance was more than .25 grams or 1 dosage unit.

STATEMENT OF PROBABLE CAUSE

In July 2025, agents of the Minnesota River Valley Drug Task Force were working with a confidential informant who stated that they could purchase cocaine from Orondi Buggs (DOB 10/6/1990).

Under the direction of law enforcement, the confidential informant arranged by 3 grams of cocaine from Buggs. The confidential informant was searched prior to the arranged buy and provided with pre-recorded buy fund money.

The confidential informant met with Buggs and completed the transaction. The confidential informant provided law enforcement with the substance that Buggs provided the informant for cash.

The substance was tested and weighed by the Bureau of Criminal Apprehension. It tested positive for cocaine and weighed 3.096 grams.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
