The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Obstruct Legal Process-Interfere w/Peace Officer

Minnesota Statute: 609.50.1(2), with reference to: 609.50.2(2)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 04/18/2025

Charge Description: On or about April 18, 2025 at 7:10 PM, in the County of Blue Earth, Minnesota, Akeem Almahdi Pendleton did, intentionally, obstruct, resist, or interfere with a peace officer while the officer was engaged in the performance of official duties and the act was accompanied by force or violence or the threat thereof.

COUNT II

Charge: Disorderly Conduct - Offensive/Abusive/Boisterous/Noisy/Obscene

Minnesota Statute: 609.72.1(3), with reference to: 609.72.1

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Charge Description: On or about April 18, 2025 at 7:10 PM, in the County of Blue Earth, Minnesota, Akeem Almahdi Pendleton did, in a public or private place, including on a school bus, knowing, or having reasonable grounds to know it will, or will tend to, alarm, anger or disturb others or provoke an assault or breach of the peace, engaged in offensive, obscene, abusive, boisterous, or noisy conduct or in offensive, obscene, or abusive language tending reasonably to arouse alarm, anger, or resentment in others.

STATEMENT OF PROBABLE CAUSE

On April 18, 2025, at 7:15 p.m., officers from the Mankato Department of Public Safety were dispatched to a disturbance that include theft of Victim 1's wallet and the suspect was running away from the scene. The suspect was identified as Akeem Almahdi Pendleton a/k/a Akeem Alham-Di Pendleton (DOB 02/09/1970).

Officer Strong was the first to encounter Pendleton who returned Victim 1's stolen checkbook, personal cards and documents. Pendleton was observed to have poor balance and officers noted a strong odor consistent with alcoholic beverage emitting from Pendleton. Pendleton became verbally aggressive with officers and yelled and screamed at the officers. Pendleton refused a PBT. Victim 1 arrived at the scene and told officers that they did not want Pendleton to be charged with theft. Pendleton was allowed to walk away from the scene.

As officers were beginning to leave, they saw Pendleton running in the middle of Cleveland Street. Officers concluded that Pendleton could not care for himself. When officers told Pendleton he was being taken to DeTox, he told officers he was not going go. Pendleton attempted to flee from officers by lunging at the officers. Officer Strong took hold of Pendleton's arm and Pendleton began to physically resist officers by pulling away and disobeying officers' command. Pendleton refused to put his hands behind his back, pulling his arms away from officers. Once handcuffed, Pendleton began to scream at officers.

Officers were finally able to control Pendleton and brought him to the holding cell at the Public Service Center. Pendleton began to scream, kick and bang his head on the cell door. Pendleton was transported to the Blue Earth County Jail and determined to be unfit for DeTox.

Pendleton is currently charged with a Controlled Substance Crime in the Third Degree in Blue Earth County District Court filed 07-CR-24-1260 and was released on his own recognizance on June 20, 2024.
