The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Traffic - DWI - Operate Motor Vehicle - Alcohol Concentration 0.08 Within 2 Hours

Minnesota Statute: 169A.20.1(5), with reference to: 169A.24.2

Maximum Sentence: 7 years and/or \$14,000.00 fine

Offense Level: Felony

Offense Date (on or about): 09/11/2023

Control #(ICR#): 23001195

Charge Description: On or about September 11, 2023, in the County of Blue Earth, said Defendant, Charles Dean Lloyd did, drive, operate, or was in physical control of any motor vehicle, when his/her alcohol concentration at the time, or as measured within two hours of the time, of driving, operating or being in physical control of the motor vehicle was 0.08 or more, and the violation was committed within ten years of the first of three or more qualified driving incidents or he/she has previously been convicted of felony D.W.I.

Charge: Traffic - DWI - Operate Motor Vehicle Under Influence of Alcohol

Minnesota Statute: 169A.20.1(1), with reference to: 169A.24.1

Maximum Sentence: 7 years or \$14,000 fine or both.

Charge Description: On or about September 11, 2023, in the County of Blue Earth, Minnesota, Charles Dean Lloyd, did, drive, operate, or was in physical control of any motor vehicle when he/she was under the influence of alcohol, and the violation was committed within ten years of the first of three or more qualified driving incidents or he/she has previously been convicted of felony D.W.I.

COUNT IV

Charge: Fleeing a Peace Officer in a Motor Vehicle

Minnesota Statute: 609.487.3

Maximum Sentence: 3 years and one day or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/11/2023

Control #(ICR#): 23001195

Charge Description: On or about September 11, 2023, in the County of Blue Earth, Minnesota, Charles Dean Lloyd did by means of a motor vehicle, flee or attempt to flee a peace officer who is acting in the lawful discharge of an official duty, and the perpetrator knows or should reasonably know the same to be a peace officer.

STATEMENT OF PROBABLE CAUSE

On September 11, 2023, Officer Guillemette of the Mapleton Police Department responded to a call of a vehicle stuck in a ditch in Blue Earth County. Witness 1 told dispatch that something was not right with the driver and that the driver offered him \$100 to help him get out of the ditch. Officer Guillemette arrived on scene and observed an individual walk around the stuck vehicle and enter the driver's seat. Officer Guillemette walked to the front passenger door, knocked on the window, and instructed the driver to turn off the vehicle. The driver of the vehicle was later identified as Charles Dean Lloyd (2/25/1962). Lloyd looked over at Officer Guillemette and Officer Guillemette noticed Lloyd had bloodshot water eyes. Lloyd then put the vehicle into drive, drove out of the ditch, then drove off on the roadway. Officer Guillemette was unable to locate Lloyd. Approximately forty minutes later Deputy Blakesley of the Blue Earth County Sheriff's Office located Lloyd and his vehicle at a residence. While speaking with Lloyd, Deputy Blakesley observed Lloyd to have glossy eyes and unstable balance. Lloyd was not willing to perform field sobriety tests or a PBT. Lloyd was arrested for suspicion of DWI and transported to the Blue Earth County Jail.

Lloyd provided a Data Master Test at the Blue Earth County Jail which resulted in .14 BAC. A review of Lloyd's Criminal history shows a felony DWI conviction in 07-CR-06-1889.
