The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Felon Convicted Crime of Violence - Firearm Violation**

Minnesota Statute: 609.165.1b(a), with reference to: 609.11.5(b)  
Maximum Sentence: 15 Years or \$30,000 fine or both.  
Offense Level: Felony

Offense Date (on or about): 10/02/2025

Charge Description: On or about October 2, 2025, in the County of Blue Earth, Minnesota, Christopher Scott Fontaine did ship, transport, possess, or receive a firearm after having been convicted of a crime of violence.

**COUNT III**

**Charge: Drugs - 3rd Degree - Possess 10 grams or more a narcotic drug other than heroin**

Minnesota Statute: 152.023.2(a)(1)  
Maximum Sentence: 20 years or \$250,000, or both  
Offense Level: Felony

Charge Description: On or about October 2, 2025, in the County of Blue Earth, Minnesota, Christopher Scott Fontaine did on one or more occasions within a 90-day period unlawfully possess one or more mixtures of a total weight of ten grams or more containing a narcotic drug other than heroin.

#### **COUNT IV**

**Charge: Drugs - 1st Degree - Sale - 17 Grams or More-Cocaine or Meth w/in 90-Day Period**

Minnesota Statute: 152.021.1(1), with reference to: 152.021.3(a)  
Maximum Sentence: 30 years or to payment of a fine of not more than \$1,000,000, or both  
Offense Level: Felony

Offense Date (on or about): 10/01/2025 to 10/02/2025

Control #(ICR#): 25028390

Charge Description: On or between October 1, 2025, and October 2, 2025, in the County of Blue Earth, Minnesota, Christopher Scott Fontaine did within a 90 day period, unlawfully sold one or more mixtures of a total weight of 17 grams or more containing cocaine or methamphetamine.

## STATEMENT OF PROBABLE CAUSE

On October 2, 2025, agents of the Minnesota River Valley Drug Task Force had a warrant to search a residence in Mankato, Minnesota, Blue Earth County. The residence was associated with Christopher Scott Fontaine (dob 5/2/1976). Fontaine has previous convictions for violent felonies and prohibits him from possessing any firearms or ammunition for life. This includes a 2018 felony conviction for 3rd degree-controlled substance possession and a 2018 felony conviction for 5th degree-controlled substance possession.

Fontaine was outside the residence and detained. Fontaine made a reference that law enforcement would find an 8-ball and a firearm inside the residence.

Inside a backpack by the couch, officers located a black Ruger 9mm pistol with live ammunition. Officers also located other 9 mm ammunition in the residence. Law enforcement also found a clear baggie with a crystal-like substance, two scales, and packaging material. The crystal-like substance field tested positive for methamphetamine weighing approximately 13.9 grams.

The prior day, law enforcement observed a vehicle leaving Fontaine's resident. The vehicle was stopped. Law enforcement arrested the driver, who was Nicholas Harroun. Law enforcement found approximately 30.6 grams of suspected methamphetamine in the vehicle.

Fontaine spoke with Agent Daily and Agent Nelson. Fontaine admitted to selling methamphetamine—around a half pound a week for the last year. Fontaine said he has sold around 20 pounds per year. Fontaine said he the firearm located in his residence is his. Fontaine admitted to selling the methamphetamine to Harroun.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
