The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Drugs - 3rd Degree - Poss. Sch 1 or 2 Narcotic, LSD, MDA, or MDMA in School/Park/Public Housing Zone

Minnesota Statute: 152.023.2(a)(4), with reference to: 152.023.3(a)

Maximum Sentence: 20 years and/or \$250,000.00

Offense Level: Felony

Offense Date (on or about): 10/19/2025

Control #(ICR#): 25030128

Charge Description: On or about October 19. 2025, in the County of Blue Earth, said Defendant Derek Darb Ruth, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, in a Park Zone.

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Charge Description: On or about October 19, 2025 at 11:06 AM, in the County of Blue Earth, Minnesota, Derek Darby Ruth, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except a small amount of marijuana, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe, after having been previously convicted of a violation of Chapter 152.

Charge Description: On or about October 19. 2025, in the County of Blue Earth, said Defendant Derek Darb Ruth did, drive, operate, or was in physical control of any motor vehicle, when the person's body contains any amount of a controlled substance listed in schedule I or II, or its metabolite

STATEMENT OF PROBABLE CAUSE

On October 19, 2025, at 11:07 a.m., officers from the Mankato Department of Public Safety were dispatched to a motor vehicle accident scene where a black Ford 150 hit two parked cars. Investigation revealed that Derek Darby Ruth (DOB 05/17/2025) was driving a 2018 Ford 150 and with Minnesota plates numbered LXZ396. Witness 1 said the Ford struck a green SUV and a Ford Focus. Witness 1 reported that Ruth had been driving and was shaking after the accident. Ruth fell asleep at the wheel before officers arrived

Officer Walker noted the following:

- Ruth appeared to have contaminated thinking as he was unable to speak in proper sentences which made sense
- Ruth talked about smelling purple
- Ruth advised that he had not used any illegal narcotics
- Ruth exhibited slurred speech and to be fidgety as he was standing with his pants unbuttoned and falling downwards towards his ankles
- At one point, I told Ruth to pull up his pants
- Ruth pulled up his pants and buttoned them
- While doing so, Ruth accessed a glass bubble pipe commonly used for ingesting illegal narcotics
- He handed the bubble pipe to Officer Sokolov
- Ruth had difficulty completing the SFST's which Officer Sokolov administered to him
- Ruth took over a minuet during the Romberg balance test which Ruth was to estimate the passing of 30 seconds and advise Officer Sokolov when he believed 30 seconds had passed by
- Officer Sokolov ended the test at over a minute, and Ruth advised he was only at 23 seconds.

Officer Sokolov had Ruth go through standard field sobriety testing and concluded that Ruth was under the influence of narcotics. Officer Pike noted that Ruth's pupils were pinpoints. Officer Pike also noticed a small gem style baggie on the dashboard. The baggie had a white substance inside that field tested positive for the presence of methamphetamine. A pipe was also located with meth residue inside the Truck. Ruth also was found to have a baggie in pocket. The baggie contained a white substance the field-tested positive for meth. The accident and the final position of Ruth's truck were inside the Washington Park Drug Enforcement Zone.

Ruth interviewed Ruth post Miranda. Ruth stated he did not remember the motor vehicle accident. Ruth said, "I think I made a mistake." A Search Warrant for a blood sample was executed and blood was drawn from Ruth for testing by the BCA Laboratory.

Ruth was transported to New Ulm Detox and remains there at the time of this complaint. Accordingly, the State Requests a Complaint Warrant.
