The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drivers' Licenses-Driving restrictions-Drive/operate/control motor vehicle w/o ignition interlock.

Minnesota Statute: 171.09.1(g)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 08/06/2026

Control #(ICR#): 26016483

Charge Description: On or about August 6, 2026, in the County of Blue Earth, Minnesota, Kallie Rose Gilman, did, while holding a restricted license issued under section 171.306, drive, operate, or be in physical control of any motor vehicle that is not equipped with a functioning ignition interlock device certified by the commissioner.

COUNT II

Charge: Traffic - Drivers License - Driving After Revocation

Minnesota Statute: 171.24.2(a)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 08/06/2026

Control #(ICR#): 26016483

Charge Description: On or about August 6, 2026, in the County of Blue Earth, Minnesota, Kallie Rose Gilman did after being given notice, or reasonably should have known of the revocation, disobeyed the order by operating in this state any motor vehicle, the operation of which requires a driver's license, while her/his license or privilege was revoked.

COUNT III

Charge: Traffic Regulation - Vehicle Registration/Permit/Plates Required

Minnesota Statute: 169.79.1

Maximum Sentence: Maximum fine of \$300.00 (Petty Misdemeanor)

Offense Level: Petty Misdemeanor

Offense Date (on or about): 08/06/2026

Control #(ICR#): 26016483

Charge Description: On or about August 6, 2026, in the County of Blue Earth, Minnesota, Kallie Rose Gilman, did operate, drive, or park a motor vehicle on any highway while the vehicle was not registered in accordance with the laws of this state.

STATEMENT OF PROBABLE CAUSE

On August 6th, 2026, Deputy Martin of the Blue Earth County Sheriff's Office was on duty working a speed enforcement shift within Blue Earth County. While on Stadium Road, Deputy Martin observed a vehicle with expired license plate registration registered to Kallie Rose Gilman (DOB: 08/16/1989). Deputy Martin observed that Gilman's license was revoked. Deputy Martin also observed that Gilman was required to have an installed ignition interlock system in any vehicle that she is driving, operating, or of which she is in physical control.

Deputy Martin activated his emergency lights and ultimately completed a traffic stop in a university parking lot near Warren Street in Mankato. The driver was identified as Gilman. Gilman provided Deputy Martin with her Minnesota Driver's License.

Gilman spoke with Deputy Martin and stated that she was aware that her license plate registration tabs were expired. Gilman also told Deputy Martin that she knew that her license had been revoked, was not valid, and that she did not have an ignition interlock device installed. Gilman advised Deputy Martin that she had paperwork at her home regarding her revoked license. Deputy Martin also noted that he did not observe an ignition interlock device in the vehicle.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
