The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Malicious Punishment of a Child-Prior Listed Offense-Less than SBH

Minnesota Statute: 609.377.3, with reference to: 609.377.3

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 06/17/2024

Control #(ICR#): 24018271

Charge Description: On or about June 17, 2024, in the County of Blue Earth, said Defendant, Timothy Peter Lorentz, did as a parent, legal guardian, or caretaker, by an intentional act or a series of intentional acts with respect to a child, evidenced unreasonable force or cruel discipline that is excessive under the circumstances; and the defendant has a previous conviction or adjudication of delinquency in the previous five years for an offense under sections 609.377, 609.221 to 609.2231, 609.224, 609.2242, 609.342 to 609.345, or 609.713.

Charge: Domestic Assault-GM-Subsequent Violation

Maximum Sentence: 364 days or \$3,000 fine or both

Charge Description: On or about June 17, 2024, in the County of Blue Earth, Minnesota, Timothy Peter Lorentz, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflicted or attempted to inflict bodily harm upon another and has a previous qualified domestic violence-related offense conviction or an adjudication of delinquency within ten years.

STATEMENT OF PROBABLE CAUSE

On July 9, 2024, at approximately 3:38 PM, Detective Erik Lopez, with the Mankato Department of Public Safety, received a child maltreatment report alleging malicious punishment of a child. The incident occurred at a residence in the City of Mankato on June 17, 2024.

Detective Lopez would learn that Timothy Peter Lorentz had maliciously punished and assaulted the seven-year-old son of his girlfriend, Witness 1. The victim (Victim 1), Lorentz and Witness 1 reside together. Witness 2, Victim 1's older brother who witnessed the incident, also resides in the home.

A video of the incident was taken by Witness 1. Detective Lopez reviewed the video as part of his investigation.

In the video Lorentz can be heard screaming at Victim 1 about cleaning up his bedroom. Lorentz can be seen throwing a red container across the bedroom nearly hitting Witness 2. Lorentz then runs across the bedroom, gets on his knees and looks under a bed where Victim 1 was hiding. Lorentz yells at Victim 1 to "get the fuck out!" Victim 1 can be heard crying.

Lorentz then grabs a hold of Victim 1 and drags Victim 1 by Victim 1's T-shirt out from under the bed. Lorentz drags Victim 1 toward a corkboard/whiteboard near the foot of the bed and throws Victim 1 into the board. Victim 1 can be heard screaming/crying and seen grabbing his lower back. Lorentz then yells, "what the fuck?"

Lorentz screams into Victim 1's face, "well pick your fucking shit up!" Victim 1 is still crying and holding his lower back. Lorentz can be heard continually yelling at Victim 1 calling him a, "dumb fucking asshole," and yelling that Victim 1 needs to pick up. During this time Victim 1 is loudly crying and holding his lower back.

Photos of Victim 1's injuries show reddening along Victim 1's spine, reddening to the lower right side of Victim 1's back and reddening to the lower right side above Victim 1's buttocks.

A check of Lorentz's criminal history reveals a conviction for Threats of Violence from October 10, 2022 (Blue Earth County file 07 - CR - 22 - 3167).
