The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Burglary - 3rd Degree - Enters w/out consent with intent to Steal/Commit Felony or Gross Misdemeanor

Minnesota Statute: 609.582.3(a)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Charge Description: On or about June 21, 2025, in the County of Blue Earth, Minnesota, Albert Brown Lurks Jr, did enter a building without consent and with intent to steal or commit any felony or gross misdemeanor while in the building, or entered a building without consent and did steal or commits a felony or gross misdemeanor while in the building, either directly or as an accomplice.

Charge: Trespass-Return to Property Within One Year

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Charge Description: On or about June 21, 2025, in the County of Blue Earth, Minnesota, Albert Brown Lurks Jr did return to the property of another within one year after being told to leave the property and not to return, and the actor is without claim of right to the property or consent of one with authority to consent.

STATEMENT OF PROBABLE CAUSE

On June 25, 2025, at approximately 3:02 PM, Ofc. Bohdan Sokolov, with the Mankato Department of Public Safety, was assigned to investigate a burglary that occurred at a grocery store in the City of Mankato.

Witness 1, who is a security officer at the grocery store, reported a burglary that had occurred at the store. Ofc. Sokolov spoke with Witness 1. Witness 1 stated that on October 21, 2024, he trespassed Albert Brown Lurks, Jr. from the store. The trespass notice barred Lurks from the store for one year. Witness 1 stated that on June 23, 2025 he confronted Lurks at the south exit of the store.

After confronting Lurks, Witness 1 reviewed the store's CCTV footage and saw that on June 21, 2025, lurks was in the store and concealed eight bottles of hemp oil valued at \$8.99 each and exited the store without paying for the bottles. The total amount of the items stolen was \$151.92.
