The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Traffic-DL-Driving after cancellation-inimical to public safety**

Minnesota Statute: 171.24.5

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 06/02/2025

Control #(ICR#): 25200926

Charge Description: On or about June 2, 2025, in the County of Blue Earth, Minnesota, Felipe Angel Hinojosa did after being given notice, or reasonably should have known of the cancellation, disobeyed the order by operating in this state any motor vehicle, the operation of which requires a driver's license, while her/his license or privilege was canceled; and the Commissioner of the Department of Public Safety has determined that the operation of a motor vehicle on the highways by the person would be inimical to the public safety or welfare.

## **STATEMENT OF PROBABLE CAUSE**

On June 2, 2025, Trooper Kevin Wellens of the Minnesota State patrol was on patrol in Blue Earth County Minnesota. Trooper Wellens observed a vehicle that had a dark window tint. Trooper Wellens ran the registration and observed the registered owner had a revoked license.

Trooper Wellens initiated a traffic stop. Trooper Wellens identified the driver as Felipe Angel Hinojosa (dob 12/18/1993). Hinojosa's driving privileges in Minnesota are cancelled as inimical to public safety.
