The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-Felony

Minnesota Statute: 609.2242.4

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/03/2025

Control #(ICR#): 25025244

Charge Description: On or about September 3, 2025, in the County of Blue Earth, Minnesota, Kathy Ann Carr did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflicted or attempted to inflict bodily harm upon another and has two or more previous qualified domestic violence-related offense convictions or adjudications of delinquency within ten years following discharge from sentence or disposition for that offense.

STATEMENT OF PROBABLE CAUSE

On September 3, 2025, at approximately 4:23 PM, Officer Marzolf of the Mankato Department of Public Safety was dispatched to a residence in Mankato, Minnesota, Blue Earth County, on report that a roommate that was drunk, belligerent, and had struck Victim 1.

Officer Marzolf arrived at the residence and spoke with Victim 1. Victim 1 stated that his roommate, Kathy Ann Carr, had been drinking all day and was intoxicated. Victim 1 stated he had taken a bottle of vodka away from Carr because it belonged to him. Carr responded by striking Victim 1 on the right side of his head.

Witness 1 confirmed Carr struck Victim 1.

Carr stated an argument happened but denied any physical contact. Carr consented to a portable breath test which had a reading of .225.

At the jail, Carr was belligerent and was repeatedly kicking the holding cell door.

Carr has a prior conviction for battery in the state of Florida with a conviction date of October 28, 2016. Carr also has a prior conviction for battery on a law enforcement officer in Florida with a conviction date of October 25, 2017.
