The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 06/04/2026

Control #(ICR#): 26017334

Charge Description: On or about June 4, 2026, in the County of Blue Earth, Minnesota, Tanya Marie Shevtsov, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe and said controlled substance was more than .25 grams or 1 dosage unit.

STATEMENT OF PROBABLE CAUSE

On June 4, 2026, Officer Strong of the Mankato Department of Public Safety responded to an address in the City of Mankato on a report of suspected controlled substances left behind in property reportedly belonging to Tanya Shetsov (DOB: 10/15/1995).

Officer Strong spoke with Witness 1. She reported that she located syringes in Shetsov's property. Shetsov reportedly admitted to Witness 1 that the syringes contained methamphetamine. Residue from the syringe field tested positive for methamphetamine.

Officer Strong located Shetsov at a hospital in the City of Mankato. Officers took Shetsov into custody on a Nicollet County warrant.

During a search of Shetsov's property at the Blue Earth County Jail, staff located a bag of suspected methamphetamine. The substance field tested positive for methamphetamine and weighed .77 grams.

Shetsov has a pending 5th degree possession charge in Nicollet County Court File # 52-CR-25-342.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
