The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 01/03/2025

Control # (ICR#): 25000219

Charge Description: On or about January 3, 2025 at 3:00 PM, in the County of Blue Earth, Minnesota, Terrance Willie Terrell Boyd did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except a small amount of marijuana after having been previously convicted of a violation of Chapter 152.

STATEMENT OF PROBABLE CAUSE

On January 3, 2025, at 3:56 p.m., officers from the Mankato Department of Public Safety were dispatched to a disturbance near several apartment buildings. A black man wearing a red sweatshirt and black pants was trying to take his pants off. The suspect was associated with a black Chevy SUV with plates numbered ERT104. A female was slumped over the vehicle.

Upon arrival, officers found the female now appeared to be alert. The male was identified as Terrance Willie Terrell Boyd (DOB 10/29/1984) and he was yelling from a balcony near the top an apartment building. Officer Susa walked into the building and found Boyd was at the wrong apartment. Boyd was brought to the correct apartment.

As Officer Susa left, three witnesses reported that Boyd had thrown something off the balcony as the officer approached the building. One of the witnesses looked and found a bag that looked like it contained drugs. The witnesses were concerned about children in the area. Witnesses also reported that they had watched Boyd "freaking out" before going into the building. The officer picked up the bag and found it contained two smaller bags with a white powder that appeared to contain cocaine. The powder in the bags was later field tested positive as cocaine and weighed a 4.78 grams and 1.13 grams respectively.

Two apartment residents told officer that the man was screaming, singing and dancing in a circle before officers arrived. The man jumped up and down, causing his pants to fall down.

Boyd has pending charges in 07-CR-24-2608 Felony Controlled Substance in the 5th Degree with an omnibus hearing set for February 3, 2025. He is accused of possessing three fentanyl tablets. On August 6, 2024 Boyd was convicted of Misdemeanor Driving Under the Influence of Controlled Substance in Washington County file 82-CR-23-4837 and is on supervised probation. On March 22, 2022 Defendant was convicted of Controlled Substance Crime in the 3rd Degree in Nicollet County File 52-CR-20-174.

Terrance Boyd was arrested and transported to Detox. Accordingly, a complaint-warrant is requested.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
