The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault in the fifth degree; Gross misdemeanor-Within three years of previous conviction.

Minnesota Statute: 609.224.2(b)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 06/18/2026

Control #(ICR#): 26012962

Charge Description: On or about June 18, 2026, in the County of Blue Earth, Minnesota, Ramoan Charles Ayler, did intentionally inflict or attempt to inflict bodily harm upon another within three years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency.

STATEMENT OF PROBABLE CAUSE

On June 18th, 2026, Blue Earth County Sheriff's Deputy Guetter responded to a report of an assault within the City of Mankato. Witness 1 contacted dispatch and reported that an individual, identified as Ramoan Charles Ayler (DOB: 06/09/1992), had assaulted her fiancé, Victim 1.

Deputy Guetter arrived on scene and searched the entire property in an attempt to locate Ayler. However, Ayler was unable to be found. While on scene Deputy Guetter spoke with Victim 1 and Witness 1 regarding the incident.

Victim 1 informed Deputy Guetter that Ayler came down to Victim 1's bedroom wanting cigarettes. When Victim 1 wouldn't give Ayler cigarettes Ayler punched Victim 1 in the face and ran back up the stairs. Deputy Guetter noted swelling behind the left eye of Victim 1.

Witness 1 spoke with Deputy Guetter and confirmed that she witnessed Ayler punch Victim 1 in the face.

Ayler has a prior qualifying domestic violence offense related conviction within the last 3 years from 07-CR-25-431 for a Felony Threats of Violence conviction from March 4, 2025.

As of the writing of this Complaint, Ayler's whereabouts are unknown. Deputy Guetter attempted to locate Ayler during this incident, but Ayler was unable to be located. Additionally, Ayler has a warrant for his arrest for a probation violation in 07-CR-25-431 and he failed to appear in a case charged via Complaint Summons in 07-CR-25-4690. Due to Ayler's whereabouts being unknown and his other active warrants, a Complaint Warrant is being requested.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
