COMPLAINT

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Damage to Property - 1st Degree - Value Reduced Over \$1000

Minnesota Statute: 609.595.1(4)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/30/2025

Control #(ICR#): 25028164

Charge Description: On or about September 30, 2025, in the County of Blue Earth, Minnesota, Ronald Duane Quade III did intentionally cause damage to another person's physical property without the other person's consent, and the damage reduced the value of the property by more than \$1,000.00, as measured by the cost of repair and replacement.

STATEMENT OF PROBABLE CAUSE

On September 30, 2025, at about 12:00 p.m., Sgt. Baker of the Mankato Department of Public Safety was dispatched to investigate a criminal damage complaint at a Mankato medical facility.

Victims 1 and 2 reported that patient Ronald Duane Quade III (DOB 06/13/1996) was placed into a seclusion room due to aggressive behaviors. When in the room, he broke several items before punching out the window on the door. The medical facility did not consent to the damage.

The medical facility estimated that the cost of repair and replacement would cost approximately \$10,000.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
