The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/30/2026

Control #(ICR#): 26016681

Charge Description: On or about May 30, 2026, in the County of Blue Earth, Minnesota, Lindsey Jane Dupraz, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe and said controlled substance was more than .25 grams or 1 dosage unit.

COUNT II

Charge: Giving Peace Officer False Name-of Another Person

Minnesota Statute: 609.506.2

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 05/30/2026

Control #(ICR#): 26016681

Charge Description: On or about May 30, 2026, in the County of Blue Earth, Minnesota, Lindsey Jane Dupraz did, with intent to obstruct justice, give the name and date of birth of another person to a peace officer when that officer makes inquiries incident to a lawful investigatory stop or lawful arrest, or inquiries

incident to executing any other duty imposed by law.

STATEMENT OF PROBABLE CAUSE

On May 30, 2026, Officer Strong of the Mankato Department of Public Safety was on patrol in Mankato, Minnesota, Blue Earth County. Officer Strong initiated a traffic stop after observing the vehicle turn without a signal.

Officer Strong identified the driver. Officer Strong observed two individuals in the backseat that were not wearing their seatbelts. One of the individuals, a female, identified herself with the name and date of birth of a different person. Eventually, Officer Strong was able to identify the female as Lindsey Jane Dupraz, dob 1/26/1985. Dupraz had warrants for her arrest. She was arrested.

In her purse, Officer Strong found approximately 1 gram of suspected methamphetamine.

Once at the jail, Dupraz stated she had ingested methamphetamine and has a heart problem. She was taken to the hospital.

A warrant is requested as Dupraz will be at the hospital or a detoxification facility.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
