COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Fugitive from Justice from Other State

Minnesota Statute: 629.13

Maximum Sentence: Rendition to the demanding State

Offense Level: Felony

Offense Date (on or about): 07/21/2026

Control #(ICR#): 26015251

Charge Description: On or about July 21, 2026, in the County of Blue Earth, Minnesota, said defendant, Bojan Vuckovic is a fugitive from justice in that Bojan Vuckovic is present in Blue Earth County, Minnesota and has been charged with the commission of a crime in any other state and having fled from justice, or having been convicted of a crime in another state and having escaped from confinement, broken the terms of bail, probation, or parole, and the State of the rendition of the defendant for return to the State of Colorado has issued a warrant for the defendant's arrest and demanded the defendant's return.

STATEMENT OF PROBABLE CAUSE

Complainant makes complaint to the undersigned Judge of the above-named Court, pursuant to Minnesota Statutes sections 629.13, 629.14, and 629.15, for Court determination of probable cause to support an Order of Detention for the above-named Defendant, as follows:

On July 21, 2026, Deputies from the Blue Earth County Sheriff's Office learned that Bojan Vuckovic (DOB: 02/25/1988) was in the City of Mankato and the subject of a nationwide warrant issued in the County of Douglas, State of Colorado.

Complainant is a licensed peace officer for the State of Minnesota and employed by the Blue Earth County Sheriff's Office.

The Blue Earth County Sheriff's Office received communication from the Douglas County Sheriff's Office alleging that the above-named Defendant has committed a crime in said state and fled from justice. Deputies Davis and Schnorenberg from the Blue Earth County Sheriff's Office came into contact with Defendant in Blue Earth County, MN on July 21, 2026.

Vuckovic was charged in the State of Colorado with Attempt to Influence a Public Servant, a Class 4 Felony. That crime is punishable in the State of Colorado by imprisonment for more than one year.

Vuckovic is currently in the custody of the State of Minnesota at the Blue Earth County Jail.

The State of Colorado has confirmed there is an active felony warrant for Vuckovic, and Colorado will extradite Vuckovic from Minnesota.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
