The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Traffic - DWI - Refuse to submit to chemical test; Breath or test refusal or failure

Minnesota Statute: 169A.20.2(1), with reference to: 169A.26.2

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 09/02/2025

Control #(ICR#): 25201498

Charge Description: On or about September 2, 2025, in the County of Blue Earth, Minnesota, Madison Shalyn Trent, did, drive, operate, or was in physical control of any motor vehicle and the Defendant refused to submit to a chemical test of the person's breath upon the request of a peace officer who had probable cause to believe the person to be tested was under the influence.

COUNT II

Charge: Traffic-Drivers License-Driving After Suspension

Minnesota Statute: 171.24.1, with reference to: 171.24.1 Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 09/02/2025

Control #(ICR#): 25201498

Charge Description: On or about September 2, 2025, in the County of Blue Earth, Minnesota, Madison Shalyn Trent did after being given notice, or reasonably should have known of the suspension, disobeyed the order by operating in this state any motor vehicle, the operation of which requires a driver's license, while her/his license or privilege was suspended.

STATEMENT OF PROBABLE CAUSE

On August 29, 2025, at 7:16 p.m. Minnesota State Trooper Dellwo was dispatched to investigate a driving complaint.

Witness 1 stated that they were following a blue Chevrolet Silverado westbound on highway 60. The Silverado had Minnesota License Plates numbered EWL040. Witness 1 fully identified themselves to the dispatcher. Witness 1 stated that the Silverado was moving from lane to lane and had been in and out of the grass on the shoulders of the highway.

Trooper Dellwo located the Silverado on Highway 60 in Blue Earth County. The Trooper immediately observed the driving conduct reported. The Trooper activated the squad' emergency lights. There appeared to be no reaction to the lights and the Trooper activated the siren. The Silverado took more than a minute to stop.

The driver and sole occupant was identified as Madison Shaly Trent (DOB 05/01/1998). The trooper noted that Trent became emotional and began crying. Trent was unable to find her Driver's License in her purse. While talking with Trent the Trooper noticed a strong odor of an alcoholic beverage emanating from the vehicle. Trent's eyes were watery and bloodshot. Trent had slurred speech and swayed once out of the vehicle.

Trooper Dellwo administered three Standard Field Sobriety Tests. Trent performed the Horizontal Gaze Nystagmus, One Legged Stand and the Walk & Turn tests. Trent's performance on these tests indicated to Trooper Dellwo that Trent was under the influence of alcohol. Trent refused a Preliminary Breath Test.

Trent was arrested and transported to the Blue Earth County Jail. At 8:22 p.m., Trent was read the Breath Test Advisory and Trent indicated that she wished to speak with an attorney. Trent was given her cell phone. The attorney time was from 8:24 until 8:43 p.m. Trent ended the process at her own choosing. Trent was offered a breath test and refused to take the test. The Breath Test advisory process was completed at 8:44 p.m.

A check of Trent's driver's license revealed that he driving status is "suspended."

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
