The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Burglary-1st Deg-Dwelling-Occupied-Non-Accomplice Present

Minnesota Statute: 609.582.1(a), with reference to: 609.582.1a

Maximum Sentence: 20 years or \$35,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 10/22/2025

Charge Description: On or about October 22, 2025, in the County of Blue Earth, Minnesota, Salvitore Emerson Clay did enter a building without consent and with intent to commit a crime, or entered a building without consent and committed a crime while in the building, either directly or as an accomplice and the building is a dwelling and another person, not an accomplice, is present in it when the burglar enters or at any time while the burglar is in the building.

STATEMENT OF PROBABLE CAUSE

On October 22, 2025, officers of the Mankato Department of Public Safety were dispatched to a burglary at a residence in Mankato, Minnesota, Blue Earth County. Officers learned that an individual had walked into an apartment and stole credit cards.

Officers met with Victim 1. Victim 1 stated she was sleeping and had been woken up by her cat. Victim 1 yelled out of her room. Victim 1 then went into her living room and observed her purse on the kitchen counter was open when it should've still been closed. Victim 1 went through her purse and observed that two of her credit/debit cards were missing. Victim 1 observed an unauthorized charge on the card for \$99.

Officers obtained video surveillance from the apartment complex. In the video, officers recognized the suspect as Salvitore Emerson Clay. Clay is seen walking in the complex and trying to open several door handles until he gets to Victim 1's. Clay then opens Victim 1's door and proceeds inside. Clay can then be seen jogging down the hallway and leaving after a short period of time inside the residence.

Meanwhile, officers learned that Victim 2 reported three separate unauthorized transactions that occurred on his credit card in Mankato, totaling \$54.13. Officers were able to identify Clay as the suspect in those crimes.

Officers located Clay who stated he had disposed of the credit cards in some bushes. At the jail, Clay stated he opened Victim 1's door thinking it was a business. He admitted to opening the purse and taking cash and the cards. Clay said he used the debit card at a business to attempt to buy a phone for \$99 but it did not go through.

Regarding Victim 2's card, Clay stated he saw a car with an open door and wallet, so he grabbed the wallet. Clay admitted he used the card at three businesses for a sandwich, cigarettes, and liquor.

Clay has two prior convictions for gross misdemeanor financial transaction card fraud in 2024.

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
