The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Threats of Violence-Reckless Disregard Risk

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 03/22/2026

Control #(ICR#): 26008569

Charge Description: On or about March 22, 2026, in the County of Blue Earth, Minnesota, Aryah Jayde Keeble, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

COUNT II

Charge: Domestic Assault-Misdemeanor-Commits Act to Cause Fear of Immediate Bodily Harm or Death

Minnesota Statute: 609.2242.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 03/22/2026

Control #(ICR#): 26008569

Charge Description: On or about March 22, 2026, in the County of Blue Earth, Minnesota, Aryah Jayde Keeble, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death.

COUNT III

Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on

Another

Minnesota Statute: 609.2242.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 03/22/2026

Control #(ICR#): 26008569

Charge Description: On or about March 22, 2026, in the County of Blue Earth, Minnesota, Aryah Jayde Keeble, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another.

STATEMENT OF PROBABLE CAUSE

On March 22, 2026, Officer Cogswell of the Mankato Department of Public Safety was dispatched to the parking lot outside a business in Mankato, Minnesota, Blue Earth County, on report of a domestic incident, including that the suspect has a knife.

Officer Cogswell made contact with Victim 1 and Aryah Jayde Keeble. Victim 1 said that Keeble is her daughter and was physically assaulting her. Specifically, Keeble had grabbed Victim 1 by the hair and scratched her arm and face. Keeble was also threatening Victim 1 that she had a knife.

Victim 1 provided Officer Cogswell with a video she took that captured part of the incident. In the video, Keeble can be heard yelling and cussing at Victim 1. Victim 1 states that she needs to find Keeble a mental health facility or hospital. Keeble states, "I'll stab you before then." Keeble also states, "I'll fuck you up before [the police] get here...if I can get my hands on you before they get here, I don't give a fuck."

On scene, Keeble stated, "I hit her, yeah, I won't deny it." Keeble had a knife in her purse.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
