The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Threats of Violence-Reckless Disregard Risk

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 01/14/2025

Control #(ICR#): 25004267

Charge Description: On or about January 14, 2025, in the County of Blue Earth, Minnesota, Jordan Royce Spencer, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

STATEMENT OF PROBABLE CAUSE

On February 16, 2025, at approximately 1:54 PM, Officer Austin Cook, with the Mankato Department of Public Safety, met with Victim 1. Victim 1 had come to the Public Safety Center to inquire about getting a protective order.

Victim 1 told Officer Cook that her ex-boyfriend, Jordan Royce Spencer, has assaulted her in the past. Victim 1 stated that on November 17, 2024, officers had responded to Victim 1's residence for a domestic assault between Victim 1 and Spencer.

Victim 1 told Officer Cook that on January 14, 2025, Spencer pinned Victim 1 to the wall using his hand on her throat and told her, "I will fucking kill you." Victim 1 reported that she felt terrorized and scared for her safety but did not report the incident to police as she was scared of what Spencer would do.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
