The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-GM-Subsequent Violation

Minnesota Statute: 609.2242.2

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 04/27/2026

Control #(ICR#): 26012890

Charge Description: On or about April 27, 2026, in the County of Blue Earth, Minnesota, Goy John Kang, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another and has a previous qualified domestic violence-related offense conviction or an adjudication of delinquency within ten years.

STATEMENT OF PROBABLE CAUSE

In the early morning hours of April 27, 2026, Officers from the Mankato Department of Public Safety were dispatched to a residence in the City of Mankato, Blue Earth County, following a domestic assault report. The caller advised two men were arguing and the caller heard loud banging coming from the men's unit.

When Officer Cook arrived to the residence, he observed blood in the hallway of the apartment complex leading to blood on the outside of the door to the unit where the reported assault had occurred. Cook knocked on the door and a male answered. The male had blood on his shoulder and knuckles. He was identified as Goy John Kang (DOB: 08/13/1997). Kang told Cook that Kang was the only person home and Kang's father left the residence. Kang said he started an altercation with his father. Kang admitted to pushing and punching his father, admitting that his emotions had gotten out of control under the influence of alcohol and during an argument. Kang provided a PBT sample and the result was .213 AC.

Officer Hermanson encountered Kang's father, Victim 1, on the exterior of the apartment building. Hermanson noted Victim 1 had blood on his face and torso.

Kang was convicted of Domestic Assault on May 25, 2017, in Court File No. 70-CR-16-6279.

Kang is currently in a detoxification facility, and the State requests a Warrant.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
