**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Liquor-Purchase/Sell/Barter/Furnish/Give to u/21yr**

Minnesota Statute: 340A.503.2(1)

Maximum Sentence: 364 days and/or \$3,000 fine

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/17/2025

Control #(ICR#): 25020424

Charge Description: On or about July 17, 2025, in the County of Blue Earth, Minnesota, Noah Demeter Schruin did sell, barter, furnish or give alcoholic beverages to a person under 21 years of age.

## STATEMENT OF PROBABLE CAUSE

July 17, 2025, at approximately 7:38 PM, officers from the Mankato Department of Public Safety learned of a liquor law violation at Riverfront Park during a concert. A bartender, identified as Witness 1, reported that Noah Demeter Schruin had come to the bar and bought two alcoholic drinks. Witness 1 stated she requested his ID and then provided the alcoholic drinks to Schruin.

Witness 1 stated that Witness 2 and Witness 3 were standing near Schruin. Both Witness 1 and Witness 2 are under the age of 21. Witness 1 stated that after she gave the alcoholic drinks to Schruin, she watched as Schruin and Witness 2 and Witness 3 walked away and Schruin handed an alcoholic beverage to Witness 2. Witness 1 stated a short time later she noticed that Witness 3 was holding a beer that Schruin had purchased.

Law enforcement made contact with Witness 2 and Witness 3. Witness 2 provided a PBT sample that reported .213. Witness 3 provided a PBT sample that reported .153.

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
