The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Criminal Sexual Conduct - 5th Degree - Penetration - Nonconsensual**

Minnesota Statute: 609.3451.1, with reference to: 609.3451.3(a)

Maximum Sentence: 2 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/27/2025

Control #(ICR#): 25027754

Charge Description: On or about September 27, 2025, in Blue Earth County, Minnesota, Joshua Stanley Olivares did engage in nonconsensual sexual penetration with another person.

## STATEMENT OF PROBABLE CAUSE

On September 27, 2025, officers from the Mankato Department of Public Safety received a report of a sexual assault that occurred between 2:30 a.m. and 4:00 a.m.

Officer Ellis met with Victim 1 at the local Emergency Room. Victim 1, an adult female, reported that she was out with a group of people that included Joshua Stanley Olivares (DOB 10/25/2002). The group went to a residence in Mankato and as people were leaving, Olivares obtained an Uber to take Victim 1 back to her apartment. Olivares rode along with Victim 1's Uber which took them to Victim 1's apartment. Victim 1 told officers she did not recall much of what happened except that Olivares asked Victim 1 for sex. At some point Victim 1 found herself on her stomach and Olivares was sexually penetrating Victim 1's vagina. Victim 1 told Olivares "no" several times. At that time she was crying. Olivares did not use a condom. Victim 1 told Olivares to leave the apartment. Olivares left. A few hours later, Victim 1 found blood on her sheets.

Investigation revealed a video of Victim 1 with Olivares at a pizza place downtown. Another video showed Olivares kissing Victim 1 on South Street and Victim 1 clearly did not want the kiss and communicated that to Olivares. Later, when Olivares rode in the Uber with Victim 1, she did not want Olivares to enter her apartment. At her door, she told Olivares "bye" and expected him to leave, but instead Olivares followed her into the apartment. Victim 1 told Officer Ellis that Olivares penetrated her vagina with his fingers and later wanted to perform oral sex on Victim 1 and she tried to push his head away. Officer Ellis accessed Department of Vehicle Services and located a photo of Olivares. Victim 1 identified Olivares as the one who sexually assaulted her.

On October 14, 2025, Detective Michael Sack obtained a Search Warrant to obtain a known DNA sample from Joshua Stanley Olivares (DOB 10/25/2002). DNA analysis of Victim 1's genitalia and inner thighs concluded that neither Joshua Olivares nor any of his paternally related male relatives can be excluded. Further DNA testing is anticipated.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
