The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/22/2025

Control #(ICR#): 25020847

Charge Description: On or about July 22, 2025, in the County of Blue Earth, Minnesota, Robert Lee Heck, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except a small amount of marijuana, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe, after having been previously convicted of a violation of Chapter 152.

STATEMENT OF PROBABLE CAUSE

On July 22, 2025, at approximately 6:20 PM, Ofc. Calleigh Cogswell with the Mankato Department of Public Safety, was dispatched to a store in the City of Mankato on a past occurred shoplifting. The complainant, Witness 1, who works with the store's loss prevention department, reported that Robert Lee Heck was in the store and had a recent shoplifting incident involving an electric bike.

Ofc. Cogswell responded to the store and spoke with Witness 1. Witness 1 reported that Heck had shoplifted from the store on July 12, 2025, and they had located him in the store on today's date.

Witness 1 and Ofc. Cogswell walked around the store and were able to locate Heck. Witness 1 and Ofc. Cogswell asked Heck to accompany them to the loss prevention office so they could speak with him about the previous shoplifting incident.

On their way back to the office, Ofc. Cogswell ran Heck's identification information and learned that Heck had multiple warrants for his arrest in the Blue Earth County. Ofc. Cogswell placed Heck under arrest and he was transported to the Blue Earth County jail.

Once at the jail, Heck and his backpack were searched by Ofc. Austin Cook. Ofc. Cook located a gray felt bag in Heck's backpack. Inside of the bag Ofc. Cook located a clear bubble pipe with burnt residue inside and a blue bag with a white crystalline substance inside. The substance would later test positive for the presence of methamphetamine and weigh approximately .14 g.

A check of Heck's criminal history reveals two prior convictions under Chapter 152. The latest such conviction can be found in Blue Earth County file 07-CR-23-1959 (an October 24, 2023 conviction for a Fifth Degree Controlled Substance Crime).

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
