The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Kidnapping-To Commit Great Bodily Harm/Terrorize**

Minnesota Statute: 609.25.1(3)

Maximum Sentence: 40 Years or \$50,000 or both

Offense Level: Felony

Offense Date (on or about): 05/11/2026

Control #(ICR#): 26014541

Charge Description: On or about May 11, 2026, in the County of Blue Earth, Minnesota, Miguel Angel Reyes, did confine or remove from one place to another, any person without the person's consent, or, if the person is under the age of 16 years, without the consent of the person's parents or other legal custodian, and did so with the purpose to commit great bodily harm or to terrorize the victim or another; and the victim was released in a safe place without great bodily harm.

**COUNT II**

**Charge: False Imprisonment-Intentional Restraint**

Minnesota Statute: 609.255.2

Maximum Sentence: 3 years or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/11/2026

Control #(ICR#): 26014541

Charge Description: On or about May 11, 2026, in the County of Blue Earth, Minnesota, Miguel Angel Reyes, did, while knowingly lacking lawful authority to do so, intentionally confined or restrained another person without the person's consent.

**COUNT III**

**Charge: Domestic Assault-Misdemeanor-Commits Act to Cause Fear of Immediate Bodily Harm or Death**

Minnesota Statute: 609.2242.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 05/11/2026

Control #(ICR#): 26014541

Charge Description: On or about May 11, 2026, in the County of Blue Earth, Minnesota, Miguel Angel Reyes, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death.

## STATEMENT OF PROBABLE CAUSE

On May 11, 2026, at approximately 4:36 p.m., Officers of the Mankato Department of Public Safety responded to Residence 1 in the City of Mankato to investigate a kidnapping report.

Officer Sokolov spoke with Witness 1. She went to pick up her three children at Residence 1 after a doctor's appointment. Her ten-year old daughter, Victim 1, was not at Residence 1.

Witness 1 called her cell phone, but there was no answer. She followed her daughter's GPS signal and located her brother's vehicle at Business 1. Witness 1 followed the vehicle. It returned to Residence 1 where Witness 1's brother, Miguel Angel Reyes (DOB: 4/29/1983), exited the vehicle with Victim 1, who appeared to be having a panic attack. Witness 1 reported that Reyes is schizophrenic and appeared to be high on methamphetamine. Witness 1 stated that Reyes said he was a demon and the devil was coming. Witness 1 did not consent to Reyes taking Victim 1.

Victim 1 reported that Reyes had arrived at Residence 1, grabbed her by the arm, and pulled her into his car, a 2019 silver Chevrolet Traverse, plate: HPV505. Victim 1 reported that Reyes drove erratically and aggressively, talked nonsensically, made her crouch down and hide on the backseat floorboard because the cameras were watching, and took her phone away from her.

Victim 1 further reported that Reyes was trying to find his own children who he said were demon-possessed. Reyes used Victim 1's Snapchat maps to try to locate his own children. Reyes' parental rights were recently terminated. Victim 1 was fearful, and was unable to flag anyone down from the vehicle, or call for help, because Reyes took her phone.

Officers took Reyes into custody and transported him to Hospital 1, where officers placed a transport hold. Accordingly, the State requests a complaint warrant.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
