The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Aggravated Robbery-1st Degree**

Minnesota Statute: 609.245.1, with reference to: 609.245.1

Maximum Sentence: 20 years or \$35,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/12/2025

Control #(ICR#): 25013530

Charge Description: On or about May 12, 2025, in the County of Blue Earth, Minnesota, Kody William Roberts, did, while committing a robbery, possess a dangerous weapon or any article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon or inflicted bodily harm upon another.

**COUNT II**

**Charge: Aggravated Robbery-2nd Degree**

Minnesota Statute: 609.245.2

Maximum Sentence: 15 Years or \$30,000 fine or both.

Offense Level: Felony

Offense Date (on or about): 05/12/2025

Control #(ICR#): 25013530

Charge Description: On or about May 12, 2025, in the County of Blue Earth, Minnesota, Kody William Roberts, did, while committing a robbery, implied, by word or act, possession of a dangerous weapon.

## STATEMENT OF PROBABLE CAUSE

On May 13, 2025, Officers of the Mankato Department of Public Safety learned of an armed robbery overnight. The suspect was identified as Kody William Roberts (DOB 10/25/1995).

Investigation revealed that the robbery took place in a Mankato Residence on May 12. Victim 1 reported that Roberts showed up at the residence and pulled a gun out. Roberts demanded Victim 1's money. Victim believed it was a real gun and gave Roberts \$180. A witness reported that the gun looked like a Glock handgun.

Victim 1 returned to the Mankato residence on May 13<sup>th</sup> and Roberts returned and pulled the gun on him again and demanded money. Victim did not give Roberts any more money and was able to leave the residence.

A witness at the residence that morning stated that they were with Roberts and when Victim 1 arrived, Roberts "freaked out" and pulled a gun on Victim 1. The witness described it as a black handgun, but did not know if it was a real gun. Victim 1 fled the scene.

On May 14, 2025, officers arrested Kody Roberts on outstanding warrants. The gun was located in Robert's bag along with Roberts ID. The gun looked like a Glock but was a BB gun.

Officer Sokolov administered a photo line-up to Victim 1. Victim 1 identified Roberts' photo as the man who robbed him.

Roberts has been convicted of seven felonies in the last ten years:

62-CR-22-5451 Ramsey County Simple Robbery (07/06/2023)  
07-CR-21-2379 Felony Assault 4<sup>th</sup> Degree Peace Officer (03/28/2024)  
07-CR-19-4757 Felony Controlled Substance 5<sup>th</sup> Degree(11/13/2019)  
07-CR-18-4184 Felony Controlled Substance 5<sup>th</sup> Degree(11/13/2018)  
07-CR-18-2495 Burglary in the 3<sup>rd</sup> Degree (11/13/2018)  
07-CR-16-362 Felony Controlled Substance 5<sup>th</sup> Degree (03/16/2016)  
07-CR-15-1946 Felony Controlled Substance 5<sup>th</sup> Degree (03/16/2016)

Roberts has two pending felony files in Blue Earth County: 07-CR-24-4559 (Receiving Stolen Property) and 07-CR-25-1927 (Controlled Substance Crime in the 5<sup>th</sup> Degree: Methamphetamine). The two cases are scheduled for June 24<sup>th</sup> at 3:00 p.m.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
