COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Liquor-Purchase/Sell/Barter/Furnish/Give to u/21yr

Minnesota Statute: 340A.503.2(1), with reference to: 340A.702(8)

Maximum Sentence: 364 days in jail, \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 08/19/2026

Control #(ICR#): 26026228

Charge Description: On or about August 19, 2026, in the County of Blue Earth, Minnesota, Peter David Whiteman did sell, barter, furnish or give alcoholic beverages to a person under 21 years of age.

STATEMENT OF PROBABLE CAUSE

In the morning on August 19, 2026, Sergeant Wilkins and Officer Mohr from the Mankato Department of Public Safety conducted an Alcohol Sales Compliance check at Business 1 in the City of Mankato. Witness 1, who is 19-years-old, went into Business 1 and ordered a beer, which she was served by Peter David Whiteman (DOB: 07/13/1983). Whiteman admitted to Sergeant Wilkins and Officer Mohr that Whiteman did not ask for Witness 1's driver's license or look at it before serving Witness 1 the beer. Whiteman denied selling the beer to Witness 1 knowing Witness 1 was under 21 years of age.
