The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Stalking - Engages in Stalking

Minnesota Statute: 609.749.5(a) Maximum Sentence: 10 years, or \$20,000 fine, or both Offense Level: Felony

Offense Date (on or about): 07/18/2025

Control #(ICR#): 25020542

Charge Description: On or about July 18, 2025, in the County of Blue Earth, Minnesota, Fridah Wamaitha Kamande, did engage in stalking with respect to a single victim or one or more members of a single household which the actor knows or has reason to know would cause the victim under the circumstances to feel terrorized or to fear bodily harm and which does cause this reaction on the part of the victim.

COUNT II

Charge: Domestic Abuse No Contact Order - Violate No Contact Order - Misdemeanor

Minnesota Statute: 629.75.2(b) Maximum Sentence: 90 days or \$1,000 fine, or both. Offense Level: Misdemeanor

Offense Date (on or about): 07/18/2025

Control #(ICR#): 25020542

Charge Description: On or about July 18, 2025, in the County of Blue Earth, Minnesota, Fridah Wamaitha Kamande did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order.

STATEMENT OF PROBABLE CAUSE

On May 15, 2025, Victim 1 called police to report an argument with Victim 1's girlfriend, Fridah Wamaitha Kamande (DOB: 05/12/2006) turned physical when Kamande bit Victim 1 multiple times. Victim 1 also reported Kamande told Victim 1 that Kamande wanted to kill Victim 1 and then kill herself. As a result of this incident, the Honorable Bradley Walker, Judge of District Court, issued a Domestic Abuse No Contact Order ("DANCO") on May 16, 2025, in Court File No. 07-CR-25-1942. The DANCO prohibits Kamande from having any "contact directly, indirectly or through others, in person, by telephone, in writing, electronically or by any other means" with Victim 1. It also prohibits Kamande from going to Victim 1's residence. Kamande was personally served with a copy of the DANCO at 3:20 p.m. on May 16, 2025.

On May 20, 2025, Witness 1 reported that immediately after Kamande was released from the Blue Earth County Jail, Kamande violated the DANCO by entering Victim 1's apartment while Victim 1 was home. Victim 1 confirmed the accuracy of Witness 1's report to police.

On June 22, 2025, Kamande called 911 and said Kamande wanted to die by suicide. Police responded to Kamande's residence and found a kitchen-style knife on Kamande's bed and several pill bottles and cleaning solution in the residence. Kamande admitted to police Kamande consumed cleaning solution and pills in an effort to die by suicide.

On July 3, 2025, Kamande sent messages about suicide to Kamande's employer. Police then located Kamande with Victim 1 in Kamande's vehicle in the parking lot of Victim 1's apartment building. Victim 1 told police Kamande was manipulating Victim 1 by making statements about suicide.

On July 14, 2025, multiple people reported a female was screaming uncontrollably in the parking lot outside Victim 1's apartment building. When police contacted Kamande, Kamande said she was going to cut herself and break her own arms and demanded that police kill her. Video surveillance showed that Kamande chased Victim 1 on the property of Victim 1's apartment building and gained entry into Victim 1's apartment unit before police were called during this incident. Witnesses confirmed these events.

On July 18, 2025, Victim 1 reported Kamande sent Victim 1 messages on Instagram and called Victim 1. The following day, Officer Courtney Walker spoke with Victim 1 at Victim 1's residence in the City of Mankato, Blue Earth County, regarding the contact by Kamande. Victim 1 showed Officer Walker photographs of the messages from Kamande. Victim 1 told Officer Walker that Kamande told Victim 1's parents, "[Victim 1] is going to pay for this." Victim 1 reported Victim 1 was scared and stressed to the point Victim 1 called in sick for work.

Victim 1 requested an emergency lease termination from Victim 1's apartment building because of Kamande's ongoing, unwanted contact and conduct. Victim 1 told Officer Walker Victim 1 fears Kamande will assault Victim 1 when Kamande is released from custody.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be: (1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or (2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
