**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Threats of Violence-Reckless Disregard Risk**

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 02/08/2026

Control #(ICR#): 26004020

Charge Description: On or about February 8, 2026, in the County of Blue Earth, Minnesota, Nyakim Lual Yien, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

**COUNT II**

**Charge: Assault - 4th Degree - Peace Officer - Physically Assaults**

Minnesota Statute: 609.2231.1(b)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

##### **Charge: Obstruct Legal Process-Lawful Execution Legal Process**

Minnesota Statute: 609.50.1(1), with reference to: 609.50.2(2)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 02/08/2026

Charge Description: On or about February 8, 2026, in the County of Blue Earth, Minnesota, Nyakim Lual Yien did and intentionally obstruct, hinder or prevent the lawful execution of any legal process or the apprehension of another on a charge or conviction of a criminal offense and the above act was accompanied by force or violence or the threat thereof.

#### **COUNT V**

##### **Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on Another**

Minnesota Statute: 609.2242.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 02/08/2026

Control # (ICR#): 26004020

Charge Description: On or about February 8, 2026, in the County of Blue Earth, Minnesota, Nyakim Lual Yien, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another.

## STATEMENT OF PROBABLE CAUSE

On February 8, 2026, at approximately 7:00 PM, officers from the Mankato Department of Public Safety were dispatched to a residence in the City of Mankato on a report of a domestic situation. It was reported that the mother, Victim 1, at the residence had been locked out by her daughter, Nyakim Lual Yien. It was initially reported that Yien may have a knife.

Ofc. Maxwell Strong responded. Upon arriving at the scene, Ofc. Strong made contact with Victim 1. Victim 1 stated that she lives with Yien and that Yien had pushed her out of the residence and locked the door on her. Victim 1 stated that she was fearful of Yien as Yien was screaming and had pushed her.

Yien then came to the door of the residence and opened it. Yien immediately started walking back into the residence. Ofc. Strong followed in an attempt to gather Yien's side of the story. Yien walked into her bedroom and laid down on the bed. Yien then threw her cell phone at Officer Strong, striking him in the chest.

In an attempt to de-escalate the situation and effectuate an arrest, Ofc. Strong took a hold of Yien's wrist/forearm and escorted her to the floor. Yien physically resisted as officers attempted to place her in handcuffs. Yien kicked at Ofc. Colton Pike on multiple occasions while officer Strong was attempting to place Yien into handcuffs. One kick connected with Ofc. Pike in his upper leg area. Ultimately officers were able to place handcuffs on Yien.

Once Yien was secured in handcuffs, officers escorted her outside to a squad car. Yien was transported to the Blue Earth County jail. During transport to the jail, Yien threatened Ofc. Pike stating, "I'm finna kill your ass" and "you got a little sister? I'll finna kill her ass too."

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
