The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Traffic-DL-Driving after cancellation-inimical to public safety

Minnesota Statute: 171.24.5

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 04/12/2026

Control #(ICR#): 26007497

Charge Description: On or about April 12, 2026, in the County of Blue Earth, Minnesota, Jonathan Andrew Mueller did after being given notice, or reasonably should have known of the cancellation, disobeyed the order by operating in this state any motor vehicle, the operation of which requires a driver's license, while her/his license or privilege was canceled; and the Commissioner of the Department of Public Safety has determined that the operation of a motor vehicle on the highways by the person would be inimical to the public safety or welfare.

STATEMENT OF PROBABLE CAUSE

On April 12, 2026, Sheriff's Deputy Cole Lund was patrolling eastbound on CSAH 9 leaving the city of Lake Crystal when his license plate reader alerted him to a passing vehicle with a nonvalid registered owner. Deputy Lund then ran the plate through DVS and confirmed the male registered owner, Jonathan Mueller (DOB:07-21-1975) was cancelled IPS. Deputy Cole was also able to confirm that Mueller was driving the vehicle. Deputy Lund then initiated a traffic stop on the 300 block of North Main St in Lake Crystal which is located in Blue Earth County, Minnesota. Mueller stopped in Business 1 parking lot. When Deputy Lund approached Mueller, he admitted that he did not have a valid driver's license. Deputy Lund then contacted another individual to pick him up. The Plates were left on the vehicle as is since Mueller's wife is the primary registered owner attached to the vehicle and Mueller stated that the vehicle is hers. The vehicle was transported to Mueller's residence by a valid driver.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
