The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Drugs - 3rd Degree - Possess 10 grams or more a narcotic drug other than heroin or fentanyl**

Minnesota Statute: 152.023.2(a)(1)

Maximum Sentence: 20 years or \$250,000, or both

Offense Level: Felony

Offense Date (on or about): 01/09/2026

Control # (ICR#): 26000938

Charge Description: On or about January 9, 2026, in the County of Blue Earth, Minnesota, Thomas Joe Chavez did on one or more occasions within a 90-day period unlawfully possess one or more mixtures of a total weight of ten grams or more containing a narcotic drug other than heroin or fentanyl.

## **STATEMENT OF PROBABLE CAUSE**

On January 9, 2026, Officer Koss of the Mankato Department of Public Safety observed Thomas Joe Chavez (DOB 08/15/1967) outside an apartment complex. Officer Koss learned that Chavez had a warrant for his arrest.

Officer Koss made contact with Chavez. Chavez was arrested. On his person, Officer Koss found approximately 11.96 grams of a white crystal substance that field tested positive for methamphetamine.

Chavez was taken to the jail. The jail would not accept Chavez because of concerns about detoxification. Officer Koss attempted to secure a detoxification center placement, but none of the centers could take Chavez. Chavez was eventually released to the hospital.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
