The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp**

Minnesota Statute: 152.025.2(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 02/19/2025

Control #(ICR#): 25004491

Charge Description: On or about February 19, 2025, in the County of Blue Earth, Minnesota, Jenna Marie Buie did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and said controlled substance was more than .25 grams or 1 dosage unit.

## STATEMENT OF PROBABLE CAUSE

On February 19, 2025, Officer Marzolf of the Mankato Department of Public Safety was dispatched to a hospital in Blue Earth County. Hospital staff called then and stated that they had found suspected narcotics among a patient's belongings. The patient was identified as Jenna Marie Buie.

Officer Marzolf met with a nurse—Witness 1. Witness 1 stated Buie had suffered a sudden unexplained decline in health. Witness 1 looked through Buie's belonging in an attempt to guide medical decisions. Witness 1 found suspected narcotics, including cut straws, foil pieces with burn residue, and several small containers with a substance. Officer Marzolf observed a small amount of white crystal clean substance that appeared to be consistent with methamphetamine.

The substance was later sent to the Bureau of Criminal Apprehension for formal testing. The crystal substance tested positive for methamphetamine and weighed approximately .53 grams.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
