The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### **COUNT I**

**Charge: Domestic Assault-GM-Subsequent Violation** 

Minnesota Statute: 609.2242.2

Maximum Sentence: 364 days or \$3,000 fine or both

Offense Level: Gross Misdemeanor

Charge Description: On or about June 4, 2024, in the County of Blue Earth, Minnesota, Timothy Peter Lorentz, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflicted or attempted to inflict bodily harm upon another and has a previous qualified domestic violence-related offense conviction or an adjudication of delinquency within ten years.

#### **COUNT II**

**Charge: Domestic Assault-GM-Subsequent Violation** 

Minnesota Statute: 609.2242.2

Maximum Sentence: 364 days or \$3,000 fine or both

Offense Level: Gross Misdemeanor

Charge Description: On or about June 4, 2024, in the County of Blue Earth, Minnesota, Timothy Peter Lorentz did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death and has a previous qualified domestic violence-related offense conviction or an adjudication of delinquency within ten years.

### STATEMENT OF PROBABLE CAUSE

On June 4, 2024, officers from the Mankato Department of Public Safety were dispatched a residence in Blue Earth Count to a report of a domestic assault occurring. Victim stated that Timonthy Peter Lorentz (9/22/1984) was drunk, kicking things around, and had physically hurt them. While responding to the call officers learned that Lorentz has left the scene on a bicycle not wearing a shirt or shoes. Victim 1 stated they had a child with Lorentz. Once on scene officers observed Victim 1 to be upset and concerned of Lorentz's return. Victim 1 stated that Lorentz had hit her across the chin and hurt her arm when forcing the phone away from her when she attempted to call a family member. Officers also observed furniture items overturned and items strew around the home which was consistent with Victim 1's story of Lorentz kkicking around items in an attempt to intimidate and scare her.

Lorentz was located and placed under arrest. Lorentz provided a PBT of .265 BAC and ultimately transported to the Blue Earth County Jail. A review of Lorentz's criminal history shows a conviction for felony threats of violence in 07-CR-22-3167.
