The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Traffic - DWI - Operate Motor Vehicle Under Influence of Controlled Substance**

Minnesota Statute: 169A.20.1(2), with reference to: 169A.27.2

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 03/22/2025

Control #(ICR#): 25200494

Charge Description: On or about March 22, 2025, in the County of Blue Earth, Minnesota, Erasmo Ozuna Jr, did, drive, operate, or was in physical control of any motor vehicle when he/she was under the influence of a controlled substance.

**COUNT II**

**Charge: Traffic - DWI - Operate Motor Vehicle Under Influence of intoxicating substance - Impaired**

Minnesota Statute: 169A.20.1(3), with reference to: 169A.27.2

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 03/22/2025

Control #(ICR#): 25200494

Charge Description: On or about March 22, 2025, in the County of Blue Earth, Minnesota, Erasmo Ozuna Jr, did, drive, operate, or was in physical control of any motor vehicle when he/she was under the influence of an intoxicating substance and he/she knew or had reason to know that the substance had the capacity to cause impairment.

**COUNT III**

**Charge: Pharmacy - Legend Drugs- Unlawful Possess/Sell/Give Away/Barter/Exchange/Distribute**

Minnesota Statute: 151.37.1, with reference to: 151.29

Maximum Sentence: 90 days jail, a \$1,000 fine, or both

Offense Level: Misdemeanor

Charge Description: On or about March 22, 2025, in the County of Blue Earth, Minnesota, Erasmo Ozuna Jr did, have in possession, sell, give away, barter, exchange, or distribute a legend drug.

##### **Charge: Motor Vehicle Registration - Unregistered - Certain Acts Forbidden**

Maximum Sentence: 90 Days and/or \$1,000.00 fine

Charge Description: On or about March 22, 2025, in the County of Blue Earth, Minnesota, Erasmo Ozuna Jr did use any number plate or registration certificate that had expired upon or in connection with a motor vehicle for which the number plate or registration certificate was not issued.

#### **COUNT V**

##### **Charge: Traffic Regulation-Uninsured Vehicle-Owner Violation**

Minnesota Statute: 169.797.2, with reference to: 169.797.4(a)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Charge Description: On or about March 22, 2025, in the County of Blue Earth, Minnesota, Erasmo Ozuna Jr did, as an owner of a vehicle with respect to which security is required under sections 65B.41 to 65B.71, operate the vehicle or permit it to be operated upon a public highway, street, or road in this state and knew or had reason to know that the vehicle did not have security complying with the terms of section 65B.48.

## STATEMENT OF PROBABLE CAUSE

On March 22, 2025, at 12:57 p.m., law enforcement officers in Blue Earth County were dispatched to investigate a driving complaint that a Trailblazer was crossing over the center and fog lines around Highway 22 and Blue Earth County Road 90. The Trailblazer also reportedly drove on the shoulder.

Blue Earth County Sheriff Deputy Lt. Othoudt found the car on 192nd Street in Blue Earth County. The vehicle was a 2002 Chevrolet Trailblazer. The driver was identified as Erasmo Ozuna, Jr. (DOB 05/01/1991).

The license plates on the vehicle had expired. The plate number was 9UE158 and expired in October 2024. Plates numbered 960AE3 had been assigned and should have been on the Trailblazer.

Minnesota State Trooper Jessie Roseberry, a Drug Recognition Evaluator, went to the scene and observed the following behaviors of Ozuna: swaying, staggering, slurred speech, and glassy eyes. The Trooper also noted that Ozuna had slow motor movements and was "obviously intoxicated."

The Trooper had Ozuna perform the Horizontal Gaze Nystagmus, One Leg Stand and Walk & Turn tests. Ozuna's performance on the field sobriety tests and his behavior indicated that Ozuna was under the influence of narcotics.

A Search Warrant was obtained and served on Ozuna. Ozuna agreed to allow a blood draw. BCA DWI Blood Collection Kit B474070 was used. The blood sample was drawn at 3:25 p.m. The sample was sealed and sent to the BCA.

On May 5, 2025, The Minnesota Bureau of Criminal Apprehension Laboratory reported that Ozuna's blood samples revealed delta-9-THC levels of 3.9 ng/ml hydroxy-THC (active metabolite of delta-9). The Lab Report also found alpha-hydroxyalprazolam (a metabolite of alprazolam) in Ozuna's blood sample.

The occupants of the Trailblazer admitted that the vehicle was not insured. Ozuna has a pending case in Brown County which includes a count of No Insurance (08-CR-25-193).

Ozuna had a small bag slung over his shoulder under his coat. Inside the bag was a pipe with residue and a prescription pill container. Ozuna admitted using the pipe to smoke marijuana. The inside of the Trailblazer had an odor of marijuana, and the Trooper located a blunt in a cupholder and an ashtray with what appeared to be burnt marijuana.

The prescription pill container from the small bag had a very worn label with Ozuna's name on it, and indicating it contained Alazopram. Inside it were two different kinds of tablets. There were two round white tablets with the imprint of "H 502." According to [www.drugs.com](http://www.drugs.com), that imprint is for Hydroxyzine, an anti-histamine that reduces central nervous system activity and can be used as a sedative. The brand names associated with the drug include ANX, Vistaril, Atarax, and Rezine.

The other kind of tablets inside the container were white and rectangular with four sections. There were no imprints on those tablets. An imprint is legally required. There were 14 whole tablets and six half tablets. Trooper Roseberry used [www.drugs.com](http://www.drugs.com) to determine the tablets closely resembled Alazopram (Xanax).

Trooper Roseberry and Sergeant Perrin tested the tablets using an ion scanning machine and concluded they were W-18, a synthetic opioid similar to fentanyl, though about 100 times stronger on average.



## SIGNATURES AND APPROVALS
