COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Abuse No Contact Order - Violate No Contact Order - within 10 years of previous conviction

Minnesota Statute: 629.75.2(c)

Maximum Sentence: 10 days to 364 days or \$3,000 fine, or both.

Offense Level: Gross Misdemeanor

Offense Date (on or about): 03/29/2026

Control #(ICR#): 26009350

Charge Description: On or about March 29, 2026, in the County of Blue Earth, Minnesota, Joseph Scott Hoffman did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order and the violation occurred within ten years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency.

COUNT II

Charge: Domestic Abuse; Violates order for protection w/in 10 years of previous conviction/adj of delinq.

Minnesota Statute: 518B.01.14(c)

Maximum Sentence: 10 days to 364 days or \$3,000 fine, or both.

Offense Level: Gross Misdemeanor

Offense Date (on or about): 03/29/2026

Control #(ICR#): 26009350

Charge Description: On or about March 29, 2026, in the County of Blue Earth, Minnesota, Joseph Scott Hoffman did knowingly violate an order for protection within ten years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency.

STATEMENT OF PROBABLE CAUSE

On March 26, 2026, Joseph Scott Hoffman (DOB 04/17/1986), was personally served an Order for Protection (“OFP”) issued in 07-FA-26-1168 prohibiting him from having any contact with Victim.

On March 23, 2026, a Domestic Abuse No Contact Order (“DANCO”) was issued prohibiting Hoffman from having any contact with Victim. That DANCO was served on Hoffman March 23, 2026.

On March 29, 2026, at 1:10 PM, Officer Christianson of the Mankato Department of Public Safety was dispatched to Victim’s residence for a DANCO violation. Protected Party informed Officer Christianson that Hoffman called her at 12:57 PM on March 29th. Protected Party believed Hoffman was staying at Witness 1’s residence.

Officer Christianson then spoke with Hoffmann who acknowledged calling her to “make sure she was doing ok”. When told he was not to contact her, Hoffmann responded by staying “Yeah, I don’t give a shit.”

After speaking with Hoffman, dispatch received a call from Witness 1 reporting Hoffman was intoxicated. Hoffman was located and arrested. Hoffman has three pending criminal files in which he was released on conditions that include no use or possession of alcohol or non-prescribed mood altering substances (07-CR-25-4469 - Gross Misdemeanor Obstruction and Criminal Damage to Property, 07-CR-26-1151 -Gross Misdemeanor Domestic assault and Gross Misdemeanor Obstruction, and 52-CR-26-47 – Gross Misdemeanor DWI and Obstruction).

In addition to the previously referenced pending criminal matters, Hoffman was previously convicted of 5th Degree Assault in 07-CR-25-3248 on December 30, 2025.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
