The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp**

Minnesota Statute: 152.025.2(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/02/2024

Control #(ICR#): 24024160

Charge Description: On or about September 2, 2024, in the County of Blue Earth, Minnesota, Isaac Logan Harms did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and said controlled substance was more than .25 grams or 1 dosage unit.

**COUNT II**

**Charge: Carry BB Gun/Rifle/Shotgun/Aslt Wpn-Public Place**

Minnesota Statute: 624.7181.2

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 09/02/2024

Control #(ICR#): 24024160

Charge Description: On or about September 2, 2024, in the County of Blue Earth, Minnesota, Isaac Logan Harms did carry a BB gun in a public place.

## STATEMENT OF PROBABLE CAUSE

On September 2, 2024, at 6:03 p.m., officers of the Mankato Department of Public Safety were dispatched to a call by Witness 1 who indicated passengers in a vehicle located in a parking lot of a business in Blue Earth County appeared to be smoking narcotics and one passenger possessed a black and silver handgun. Witness 1 identified the vehicle and indicated an individual who is ultimately identified as Parker Alsleben (DOB 12/24/1999) was the driver had gone into the adjacent business, had returned, and was looking for something around the vehicle. The rear passenger was occupied by an individual later identified as Isaac Harms (DOB 01/12/2003) who possessed a black and silver handgun and was waving the gun and manipulating it. Witness 1 also indicated Harms appeared to be smoking foil paper with glass.

Officers arrived on scene and observed Alsleben walking around the vehicle.

Harms was located in the rear passenger seat. Ofc. Nuedecker observed a silver and black gun positioned under the passenger seat that was identified as a BB gun. Harms admitted to Officer Nuedecker that he had grabbed the gun and was playing with it. Harms stated he had manipulated the slide and was holding the gun while the rear passenger door was open. Harms understood it would be concerning for the general public to view him in possession of the BB gun as she was clearly in view of patrons and children. A green backpack was located next to Harms's feet. Occupants of the vehicle identified the backpack as Harms's. Located in the backpack officers observed a clear plastic baggie that had a brown powdery substance that field-tested positive for methamphetamine and weighed .82g, a number of small clear plastic baggies with a white powdery residue, 4 of which were field-tested and positive for methamphetamine, a clear plastic tube with residue lining the inside, a foil containing a brown clumpy substance that field-tested positive for methamphetamine and weighed .12g, and multiple other narcotics paraphernalia. Harms also had an active warrant for his arrest.

During a search of the vehicle officers located additional narcotics paraphernalia in the glove box. A black backpack was located in the hatch that contained 21g of THC concentrate, a clear plastic baggie containing a white crystal like substance that field-tested positive for methamphetamine and weighed .58g, and a stun gun located in the driver's compartment door. Also located on Alsleben was a clear plastic Ziploc style baggie containing a large amount of a green leafy substance that appeared to be marijuana. When asked about the black backpack and THC vapes, Alsleben confirmed they belonged to him. When asked additional questions about the black backpack, Parker indicated he did not want to answer any more questions.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
