**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Predatory Offender - Knowingly commits act or fails to fulfill registration requirement**

Minnesota Statute: 243.166.5(a)(1)

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 01/26/2026

Control #(ICR#): 26002665

Charge Description: On or about January 26, 2026, in the County of Blue Earth, Minnesota, Roy Steven Schweim did, as a person required to register under section 243.166 who was given notice, knows, or reasonably should know of the duty to register and who knowingly committed an act or failed to fulfill a requirement that violates any provision of this section.

## STATEMENT OF PROBABLE CAUSE

Mankato Department of Public Safety Police Officer Yajaira Casillas states that she is currently assigned to the Public Safety, Predatory Offender Registration Tracking Team (PORTT). A predatory offender, identified as Schweim Steven Schweim, is a registered Predatory Offender in the State of Minnesota. Also, Officer Casillas was aware that Schweim had an active Blue Earth County felony body only arrest warrant. Officer Casillas knows Schweim from previous calls for service and also knew of his current girlfriend and that she resides at an address in the City of Mankato.

Officer Casillas checked Schweim's Minnesota Bureau of Criminal Apprehension Registration checklist and learned of his: Primary Address; no registered Secondary Addresses; Phone Number; Employment (none listed); Vehicle(s) (none listed); and Last updated photos.

On 1/26/26, during a POR Compliance Check, Officer Casillas went to Schweim's primary listed address. Officer Casillas was informed by staff that Schweim no longer lived there and had turned his apartment key.

On 1/27/26, Officer Casillas went to an address in the City of Mankato and made contact with both Schweim and his girlfriend. Officer Casillas was invited inside and observed Schweim sitting in the living room. Officer Casillas observed numerous cardboard boxes which appeared like someone had moved in. Officer Casillas informed Schweim she was conducting a POR check on him. Officer Casillas asked Schweim how long he has been staying at Jessica's apartment. Schweim said he had been there for a couple of months. Officer Casillas asked Schweim why he had not updated his primary address and or added his girlfriend's address to his file as an other/secondary address. Schweim stated he thought he didn't have to register any longer as a POR.

Officer Casillas informed Schweim he was still listed as a POR with the State of Minnesota. Officer Casillas asked Schweim when he thought his registration was supposed to end. Schweim said he thought it was 2025. When asked, Schweim didn't have a specific date on when he thought his registration ended. Officer Casillas asked him who had informed him his registration was done and he said no one. Officer Casillas asked Schweim if he had received any official paperwork from the MN BCA POR Unit indicating he no longer had to register and he said no. Schweim was also informed he was under arrest for his body only arrest warrant which he indicated he knew he had.

Officer Casillas noted that Schweim had an apartment key for his girlfriend's place on his person when taking him into custody. Officer Casillas later spoke with the girlfriend who indicated she moved into the apartment in October 2025. She advised shortly after she moved into the apartment Schweim started staying with her since November 2025. She has some health issues and since November 2025 Schweim has been living with her to help her. Jessica said Schweim didn't move in but stayed overnight often because it was a long distance for him to go back to his place from her apartment.

Officer Casillas noted that Schweim's last change of information form was conducted on 2/11/2025 to change his phone number. Officer Casillas noted that Schweim's current phone number had not updated on his file.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
