COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Disorderly Conduct - Brawling or Fighting

Minnesota Statute: 609.72.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 09/22/2026

Control #(ICR#): 26001439

Charge Description: On or about September 21, 2026, in the County of Blue Earth, Minnesota, Dylan Alen Larson, did, did, in a public or private place, knowing, or having reasonable grounds to know it will, or will tend to, alarm, anger or disturb others or provoke an assault or breach of the peace, engaged in brawling or fighting.

STATEMENT OF PROBABLE CAUSE

On September 21, 2026, Officer Colter Killion responded to a "Disturbance/Disorderly," call for service. Dylan Alen Larson (DOB 9/13/2021) reported a physical altercation had occurred at a residence in the city of Lake Crystal, Minnesota which is located within the County of Blue Earth. Larson reported that the altercation was between himself and Spencer James Peterson (3/12/2000).

Upon arrival Officer Killion made contact with Peterson and Witness 1. Officer Killion observed Peterson had noticeable cuts on his face as well as blood on his face and hands. Peterson was also noticeably intoxicated. Peterson stated he had punched Larson and that Larson did the same to him. Witness 1 stated that Larson had thrown Peterson against a wall and attempted to choke Peterson.

While Officer Killion was speaking with Peterson and Witness 1, Larson returned to the residence. Larson stated that Peterson had accused him of messing around Witness 1, and that Peterson had punched Larson in the head. Larson also stated that he punched Peterson multiple times. Throughout Officer Killion's interaction with Peterson and Larson, Officer Killion had a difficult time keeping the two separated, as both wanting to argue with the other and both being intoxicated.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
