The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-GM-Subsequent Violation

Minnesota Statute: 609.2242.2

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 10/19/2024

Control #(ICR#): 24029491

Charge Description: On or about October 19, 2024, in the County of Blue Earth, Minnesota, Devin Deon Taylor, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflicted or attempted to inflict bodily harm upon another and has a previous qualified domestic violence-related offense conviction or an adjudication of delinquency within ten years.

STATEMENT OF PROBABLE CAUSE

On October 21, 2024, officers from the Mankato Department of Public Safety were dispatched to an apartment building in Blue Earth County for a civil standby. While in route, officers learned a verbal domestic incident had arisen at the apartment building. When Officer Strong arrived, he spoke with Victim 1. Victim 1 told Strong that Devin Deon Taylor (DOB: 09/27/1989) was Victim 1's ex-boyfriend, Taylor did not have a permanent address, and Victim 1 had allowed Taylor to stay with Victim 1. Victim 1 said Taylor slapped Victim 1 on the left side of Victim 1's face during an argument on October 19, 2024, and that Victim 1 heard her eardrum pop when Taylor slapped Victim 1. Victim 1 showed Officer Strong a video of Victim 1's face that documented how Victim 1's face had reddened and become bruised on the left side after Taylor slapped Victim 1. Taylor was convicted in the State of Minnesota of Assault in the Fifth Degree on July 15, 2019.
