COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Liquor-Purchase/Sell/Barter/Furnish/Give to u/21yr

Minnesota Statute: 340A.503.2(1), with reference to: 340A.702(8)

Maximum Sentence: 364 days jail or \$3,000 fine or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/17/2026

Control #(ICR#): 26022342

Charge Description: On or about July 17, 2026, in the County of Blue Earth, Minnesota, Robin Lee Anderson Sr did sell, barter, furnish or give alcoholic beverages to a person under 21 years of age.

STATEMENT OF PROBABLE CAUSE

On July 17, 2026, Officers Wilkins and Mohr of the Mankato Department of Public Safety were conducting alcohol sales compliance checks of businesses that sell alcoholic beverages within the city of Mankato, including Business 1.

Officer Wilkins and Officer Mohr had a controlled buyer, Witness 1, go into Business 1 to attempt to purchase an alcoholic beverage. Witness 1 was under the age of 21 and utilized her own driver's license for the attempted purchase. Witness 1's driver's license lists her date of birth and shows "UNDER 21" below her photograph.

Witness 1 entered Business 1 and was sold a six-pack of alcoholic beverages by Robin Lee Anderson (DOB: 11/20/1995). Anderson was an employee of Business 1 working at a cash register and sold the six-pack of alcoholic beverages to Witness 1. Witness 1 informed Officer Wilkins and Officer Mohr that she purchased the alcoholic beverages from Anderson after Anderson looked at her ID and then allowed the purchase.

Officers Wilkins and Mohr spoke with Anderson who admitted to the sale to Witness 1 who was under 21 years old. Anderson indicated he looked at the ID but was in a hurry as the line was forming.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
