The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Harassment; Restraining Order - Violate Restraining Order**

Minnesota Statute: 609.748.6(a)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 01/06/2026

Control #(ICR#): 26000354

Charge Description: On or about January 6, 2026, in the County of Blue Earth, Minnesota, Autumn Christine Olsen did violate a restraining order issued under M.S. 609.748.

## STATEMENT OF PROBABLE CAUSE

On 01/06/2026 Victim received a message via TikTok from Autumn Christine Olsen (DOB 1-21-1989). Witness 1 spoke with Deputy Alex Ollrich of Blue Earth Sheriff's Department via phone. Witness 1 explained that Victim's biological mother is Autumn Christine Olsen and that there is currently a Harassment Restraining Order in place out of Freeborn County. Witness 1 reported that Olsen had reached out to Victim again via Tic Tok messages. Witness 1 then sent Deputy Ollrich a screenshot that depicts a direct message to Victim's Tik Tok account from a username "Autumn." The message sent on January 6, 2026, read as, "Yo I need to know whose calling me from blue earth." Another message on January 7, 2026, read as, "I dunno what's going on with being a reason of blue earth phone calls balling me and them dumb bitches in your place tried to lie and put me in jail under false circumstances at bay so please advise that it wasn't you. I am not sure if it was you or them trying to see it upon reason I' make the call back to me an jail me fore contact these ppl are fuc op I in." Deputy Ollrich tried calling Olsen but received no answer.

On January 7, 2026, Autumn Olsen called Blue Earth County Dispatch to return Deputy Ollrich's phone call from the previous day. Olsen was then transferred to Deputy Ollrich's work cell phone. Olsen immediately speaking. Olsen's speech was extremely slurred and difficult to understand. Olsen stated that, "if [Victim] goes on the Tik Tok account, that's [Victim's fault]." Olsen indicated that the Tik Tok account is a family account and that the messages were sent to that account and Victim has access to it if she wants to go on it.

Victim is daughter Olsen, but Victim currently lives in foster care with her Guardian in Mankato, Minnesota, within Blue Earth County. Olsen's parental rights were terminated in Freeborn County. There is currently a Harassment Restraining Order signed by the Honorable Judge Ross Leuning which is in effect until 10/28/2027 that states that Olsen shall have no direct or indirect contact with Victim who is the protected party. On November 19, 2025, Jacob Stockwell duly served the Harassment Restraining Order on Autumn Christine Olsen. In addition, Olsen has a pending Court file regarding an HRO violation with the same Victim in December 2025.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
