The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Violate No Contact Order - Within 10 years of the first of two or more convictions**

Minnesota Statute: 629.75.2(d)(1)

Maximum Sentence: 30 days to 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 12/06/2025

Control #(ICR#): 25020505

Charge Description: On or about December 6, 2025, in the County of Blue Earth, Minnesota, Kyle Rodney Boeck did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order and the violation occurred within ten years of the first of two or more previous qualified domestic violence-related offense convictions or adjudications of delinquency.

**COUNT II**

**Charge: Domestic Abuse; Violates 2 or more OFPw/in 10 years of previous conviction/adj of delinq.**

Minnesota Statute: 518B.01.14(d)(1)

Maximum Sentence: 30 days to 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 12/06/2025

Control #(ICR#): 25020505

Charge Description: On or about December 6, 2025, in the County of Blue Earth, Minnesota, Kyle Rodney Boeck did knowingly violate an order for protection within ten years of the first of two or more previous qualified domestic violence-related offense convictions or adjudications of delinquency.

## STATEMENT OF PROBABLE CAUSE

Early in the morning on December 6, 2025, Deputies from the Blue Earth County Sheriff's Office were dispatched to Residence 1 in Blue Earth County after Kyle Rodney Boeck (DOB: 12/25/1984) reported Victim 1 assaulted Boeck there.

Boeck told Deputy Blakesley that Victim 1 showed up at Residence 1 a day or two ago and Boeck let Victim 1 stay there.

Victim 1 told Deputy Compton that Victim 1 had been at Residence 1 earlier in the night on December 5 or December 6, 2025, and claimed Boeck drove Victim 1 there after picking up Victim 1 from Victim 1's residence and despite Victim 1's request that Boeck drive Victim 1 to the Crisis Center instead.

On July 21, 2025, in Court File 22-CR-25-434, The Honorable Troy G. Timmerman, Judge of District Court, issued a Criminal Domestic Abuse No Contact Order ("DANCO") that prohibits Boeck from having contact with Victim 1. This Order was issued in open court with Defendant present. The DANCO was in effect on December 6, 2025.

On January 26, 2024, in Court File 07-FA-24-309, an Order For Protection was issued prohibiting Boeck from having contact with Victim 1, and the order was served on Defendant by personal service on February 1, 2024. The Order for Protection was in effect on December 6, 2025.

Boeck has the following convictions for qualified domestic violence-related offenses: (1) OFP Violation – Court File No. 07-CR-24-1865 – October 1, 2024; (2) OFP Violation – Court File No. 07-CR-24-417 – October 1, 2024; and (3) Threats of Violence – Court File No. 83-CR-16-183 – June 28, 2016.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
