The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Obstruct Legal Process-Interfere w/Peace Officer

Minnesota Statute: 609.50.1(2), with reference to: 609.50.2(2)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/20/2025

Charge Description: On or about July 20, 2025, in the County of Blue Earth, Minnesota, Abshir Abdirisak Omar did, intentionally, obstruct, resist, or interfere with a peace officer while the officer was engaged in the performance of official duties and the act was accompanied by force or violence or the threat thereof.

STATEMENT OF PROBABLE CAUSE

In the morning on July 20, 2025, officers from the Mankato Department of Public Safety responded to a complaint from a residence in the City of Mankato, Blue Earth County, regarding an unknown person trying to get into the complainant's residence. Officer Emily Susa spoke to the complainant who said the unknown male was banging on her door asking to be let in. The male was later identified as Abshir Abdirisak Omar (DOB: 01/01/1999). Officer Susa spoke to Omar, who said he realized he had knocked on the wrong door because the building was very new to him. The complainant told Officer John McGuire that Omar did the same thing two days prior.

In the evening on July 20, 2025, the complainant called 911 and reported she and her friends were hiding inside Business 1 because they believed Omar was following them. Officer Yajaira Casillas responded and reviewed Officer Susa's notes from the earlier call. In the vicinity of Business 1, Officer Casillas observed a male walking who matched the description of Omar from earlier that day. The walking man stopped when he saw Officer Casillas park and exit her squad car. The man told Casillas he was Omar and Casillas reviewed the man's driver's license to confirm the man's identity.

Casillas asked Omar about following the complainant and her friends and about Omar's conversation with Officer Susa that morning. Omar acknowledged Susa told Omar not to knock on the complainant's door. Omar asked Casillas to give back Omar's driver's license, Casillas told Omar he could have it when they were done talking, but Omar was not free to go because police were investigating the complainant's report Omar was following complainant and complainant's friends.

Omar told Casillas Omar left his apartment to walk to Business 2 to urinate. Omar's demeanor changed during the conversation with Casillas and after Minnesota State Patrol Trooper Bruns arrived to assist, Omar became increasingly upset and animated. After leaning against an electrical box, Omar suddenly stood up and lunged towards Casillas in an aggressive manner, leading with Omar's chest and hands and taking an aggressive stance. Omar said to Trooper Bruns, "get her ass," referring to Officer Casillas, and then "don't treat me like that fucking pig!"

Based on Omar's escalating physical and verbal aggression, Casillas determined it was necessary to control and detain Omar for their safety and to maintain a safe investigatory environment. Casillas told Omar to turn around as Casillas took a hold of Omar's left wrist and arm to bring them behind Omar's back and place Omar in handcuffs. Omar immediately pulled Omar's arm away and yelled, "I'm not gonna fucking turn around!" and then, "let go, bitch!", bending Omar's arm toward himself to prevent Casillas from moving it behind Omar's back. Omar planted Omar's feet to prevent Casillas from moving Omar away from the electrical box and toward Casillas's squad car. Trooper Bruns took a hold of Omar's right arm to assist with controlling and detaining Omar, who continued to resist and tried to kick, moving Omar's body back and forth to attempt to break free from officers. Casillas told Omar he would get tased if Omar did not get down on the ground.

After officers directed Omar to the ground and applied handcuffs, Omar tried to get up by lifting up the right side of Omar's upper body and jerking Omar's right elbow toward officers while lifting Omar's head to look at officers. Omar said, "get the fuck off me before I blow my shit." While Casillas escorted Omar to Casillas's squad car, Omar observed a pair of handcuffs lying on the sidewalk that had fallen off Casillas's exterior vest during the struggle with Omar. Omar placed his left foot on top of the handcuffs and slung them backwards with one aggressive move.
