The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Abuse No Contact Order - Violate No Contact Order - within 10 years of previous conviction

Minnesota Statute: 629.75.2(c), with reference to: 629.75.2(c)

Maximum Sentence: 10 days to 364 days or \$3,000 fine, or both.

Offense Level: Gross Misdemeanor

Offense Date (on or about): 01/21/2026

Control # (ICR#): 26002165

Charge Description: On or about January 21, 2026, in the County of Blue Earth, Minnesota, Shea Patrick Kelly did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order and the violation occurred within ten years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency.

STATEMENT OF PROBABLE CAUSE

On January 21, 2026, Officer Keaton Rutz of the Mankato Department of Public Safety was dispatched to a Domestic Abuse No Contact Order Violation (DANCO) in Mankato MN, located within Blue Earth County, Minnesota. Victim reported that she has a DANCO against her husband, Shea Kelly and that he had contacted her. She reported he called and left her a voicemail.

Officer Rutz made contact via phone with victim and victim informed Officer Rutz that she has an active Domestic Abuse No Contact Order against her husband Shea Kelly, and he is not supposed to contact her. Victim further stated that Kelly was in a sober house facility in Rochester, Minnesota and was not supposed to have access to internet or electronics. Victim indicated that she received a phone call from her contact "She-Long Term," which she advised was the number Kelly would call from at the sober house facility. Victim did not answer the phone call, and the caller left a voicemail. Victim listened to the voicemail and advised she was positive it was Kelly since she was married to him and recognized his voice. Victim then uploaded a screenshot, transcript, and recording of the voicemail to evidence.com via a link provided by Officer Rutz. Officer Rutz then listened to the voicemail which was 23 seconds long and heard the following: "Hey, somebody's been active on my Facebook so it's either my phone or something, I'll get the information. Pictures were deleted and I'm here as a vulnerable adult and somebody that messes with that and holds a check back, there's going to be legal. I don't want that but obviously if you're on my Facebook doing that too it's proving the person you are."

Officer Rutz located a copy of the DANCO between Victim and Kelly. Officer Rutz observed that the DANCO states Kelly is not to have any contact, including by phone, with victim unless it is electronic communication regarding shared house, property, or insurance.

Kelly has a previous qualified domestic violence offense conviction from January 14, 2026, approximately one week prior to this violation.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
