**COMPLAINT**

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Threats of Violence-Reckless Disregard Risk**

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/19/2026

Control #(ICR#): 26015413

Charge Description: On or about May 19, 2026, in the County of Blue Earth, Minnesota, Teague Sterling Mayville, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

**COUNT II**

**Charge: Threats of Violence-Reckless Disregard Risk**

**COUNT III**

**Charge: Obstruct Legal Process-Interfere w/Peace Officer**

Minnesota Statute: 609.50.1(2)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 05/19/2026

Charge Description: On or about May 19, 2026, in the County of Blue Earth, Minnesota, Teague Sterling Mayville did, intentionally, obstruct, resist, or interfere with a peace officer while the officer was engaged in the performance of official duties and the act was accompanied by force or violence or the threat thereof.

#### **COUNT IV**

**Charge: Assault - 4th Degree - Peace Officer - Physically Assaults**

Minnesota Statute: 609.2231.1(b)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 05/19/2026

Control #(ICR#): 26015413

Charge Description: On or about May 19, 2026, in the County of Blue Earth, Minnesota, Teague Sterling Mayville did physically assault a peace officer when that officer was effecting a lawful arrest or executing any other duty imposed by law.

## STATEMENT OF PROBABLE CAUSE

On May 19, 2026, Law Enforcement Officers were dispatched to Business 1 located in the City of Mankato, Minnesota County of Blue Earth, regarding an individual who was acting erratically by yelling and threatening to kill people. Witness 1 called 911 and reported to Blue Earth County Dispatch that there was a man with dogs yelling and threatening to kill people. Witness 1 described the man as a white male wearing a trench coat with a big black backpack who appeared to be in his mid-30's.

Law enforcement had been made aware of this individual based on Officer Courtney Walker sending a department wide email advising that he had two separate incidents the day prior and stated that the male had a large knife on his hip during the interactions and three dogs. The male was identified as Teague Sterling Mayville (DOB: 06/25/1997). Officer Walker noted that Mayville had indicated that Mayville was in town to train for Mixed Martial Arts. Officer Walker also discovered that Mayville has several out-of-state warrants. These warrants were found to not be extraditable at this time

Officers of the Mankato Department of Public Safety arrived on scene and Mayville was immediately confrontational and was screaming loudly. Mayville conveyed that he was having a bipolar episode and needed to scream. Officer Calleigh Cogswell observed that Mayville had a sheath on his right hip at this time. Officer Walker arrived on scene, and Mayville appeared to immediately recognize him from recent interactions. Mayville then became increasingly agitated stating that Officer Walker had been stalking him. Mayville began to scream at Officers and made the following statements while looking directly at all three present Officers. The Officers present were Officer Calleigh Cogswell, Officer Courtney Walker, and Deputy Adam Suckow.

- "This is going to escalate to violence"
- "If you wanna go let's go" while throwing the dog leashes down
- "You gonna fuckin shoot me"
- "This is going to escalate to violence"
- "I am training to kill you motherfuckers, that's why I train every day." While smacking his chest.
- "This is going to escalate and spiral"
- "If you walk away right now, you guys will try to fucking follow me and put your hands on me then I'm going to have to my knife to one of your necks"
- "You're gonna have to fucking shoot me"

While making these statements Mayville had three large dogs with him as well as a large knife. Officers spoke in length with Mayville in attempts to de-escalate the situation. Officer Walker advised Mayville that he was under arrest and that he needed to put his hands behind his back as he had just threatened to stab Officers in the neck.

After some time, Mayville removed his backpack and knife and threw both away from his person. Officer Cogswell and Officer Terry approached Mayville and placed him in handcuffs. As Officers attempted to walk Mayville to the squad care, he immediately tensed up all his muscles and refused to walk. Mayville forcibly kicked closed the squad door which was open. Mayville then lunged forward at Officer Walker. During these events Mayville focused much of his anger and aggression at Officer Walker indicating that he hates him. When Mayville did that Officer Terry pulled Mayville back by the handcuffs and collar of his sweatshirt. Mayville then wrapped Officer Terry's index finger with an attempt to break his finger. This caused injury in the form of pain and stiffness that persisted into the next day. Mayville's declining cooperation and being actively resistant led to Officers assisting him to the ground. While on the ground

Officers applied the WRAP device. Mayville continued to forcibly resist Officers by flailing his body, kicking, and prevented placement of the WRAP. Mayville was medically sedated on scene due to his behavior. He was then transported to Hospital. Mayville's backpack was searched by Officer Walker and Cogswell and inside a second machete was located.

Mayville was later discharged from Hospital and transported to the Blue Earth County Jail.

## SIGNATURES AND APPROVALS
